Changes to the C2 Form/'Request for Service' Richard Baldwin has notified us of some changes to the C2 Form which agencies use to make contact with the Children's Social Care Duty Team when there is an identified concern or need. The title of the C2 Form has led to some confusion about whether or not the receipt of the C2 constituted a

'referral' or not. This has meant that on a number of occasions, agencies have understandably assumed that sending in the C2 will automatically lead to action being taken. As a result of this, we have changed the title of the C2 Form to 'Request for Service' as this more accurately clarifies the decision making process.

- Upon receipt of the C2, the Duty Social Worker will need to assess the 'Request for Service' and determine if this meets the threshold for Social Work intervention or whether other Early Help Services may be more appropriate.
- If it is decided that the 'Request for Service' requires Social Work involvement, it
  will become a 'Referral' and progress to 'Single Assessment'. If it is felt that the
  concerns could be dealt with more appropriately through intervention with other
  agencies via an Early Help approach, we will discuss with yourselves and
  partners how this can be most appropriately progressed.

Please be reassured that this clarification of the purpose of the C2 form does not change any thresholds or decision making in regard to vulnerable families. Rather, it seeks to clarify the existing arrangements and minimise confusion and any misunderstanding that the previous title of the C2 may have caused.
