#### a Storm damage.

# d Funding from PCC (Local Places for Nature grant) £3347.

Funded LCTC's recent thinning work in Compartments 1b, 5a, 5b. Plus some interpretation signs.

Removing branches from beech trees overhanging Gorsedd stones to let more light and moisture in to the driest part of the meadow.

We have planted species and sown seeds that are more suitable for the drier parts which had not faired as well as those previously planted in the wetter parts.

Anti-slip strips are being fixed to the sleeper step risers

Tree planting: we have 13 oaks intended to plant (4 replacements and 9 new) on 16 Dec. We will postpone until Jan workday when, hopefully, Severn Rivers Trust will also donate some other suitable species for us to plant.

The funding is being underwritten by LCTC, who will claim the funding back from PCC.
