- 1 Apologies for absence received from: Angela Aldis, Jim Inkster, Sam Webster and Ceri Jones. Ceri was represented at the meeting by Lottie Glover.
- 2 Nick welcomed everyone to the meeting
- Most of the actions from the previous meeting had been completed with just two remaining to be resolved:

 (12d) Nick was aware that LCTC were trying to establish ownership of the car park through the Land Registry. Nick would also suggest the TC try Powys CC.

 Following the meeting Sam provided an update which is included as a note at the end of these minutes.

 (12e) To aid the formulation of a policy about removing

certain timber from the wood Nick had summarised the issues for the Councillors of the Deri Woods sub group.

Nick will follow up with the Town Clerk.

- The Chair's report had already been presented at the AGM (see 16 Dec 22 AGM minutes).
- LCTC have a leaf blower and suggested to FoDW that it be kept in the tool store and be available for FoDW to use to clear the paths, steps and bridges. The members agreed that it would be very useful but that an alternative fuel/oil container may be required. This decision will be communicated back to LCTC.

The creation of an otter holt is dependant on locating a suitable riverside site in Deri Woods / Goat Field. While the Banwy isn't suitable the far side of the Nant Ty-Lissa might

Item 3 note. Previous action (12E):

The land comprising both the car park and Deri Woods are not registered.

Robert has contacted PCC to see where the highways land ends (it might or might not include the car park).

If that draws a blank we have to look at evidence as follows:

- Use of land what is it used for does it support the use of other land?
- Maintaining the land who maintains the land?
- Occupation of land do you occupy the land and do you shut it off once a year?
- Other evidence i.e. PCC has a litter bin on the land,
