#### **OBJECTION**

It looks like a Party Wall Agreement might be required with the owners of No. 61 for this proposed development. With the loss of the garage and the proposed addition of another bedroom there should be at least three onsite vehicle parking spaces, which there does not appear to be room for at the front of the property. There is already a problem with vehicles speeding down Grays Lane so if more vehicles are parked on the road it could lead to a possible accident.
