Aughton Hall History

- 1514 a court roll includes Aughton Manor.
- 1596 John Aske leases Aughton Manor to Helen Howdell & Margaret Cobcrofte for 21 years June 24th year not known John Aske, late of Aughton discharges Hugh Bethell of Ellerton & William Bethell from the covenant made for repairing & maintaining the Manor house & buildings in an indenture of lease
- 1602, 22nd September John Aske leases the Manors' cottage & lands to John Overton for 30 years
- 1603, 7th September A deed of covenant from William Hildyard, Thomas Scudamor & Richard Hodgson is made to John Aske
- 1605, Feb 4th Custody & marriage rights granted to Robert Snawfell Esq & William Bethell, gent of Grisilda Bethell, daughter & heir of Hugh Bethell, if Hugh should die before she is 14, to enjoy such rights until she becomes of age And Custody of Gorssell Bethell. Mentions Hugh Bethell, knight "holds in chief by miltary service" Redding Grange, Aughton, Norlande, Parkflatte, Horseclose, Nedleflatt, Acumcrofte, Sanfland, Sanflandinge, Priorstedes, Stocking, & Redding Springs in Aughton & Ellerton.
- 1606, July 28th Regrant Henry Stanley & John Standish have titles of Aughton Church with lands.
- 1606, September 26th Sir Hugh Bethell owns Aughton Church with lands.
- 1687, April 30th May 12th Accounts of workmens wages, disbursments, servants wages, holdhold accounts, estate accounts, garden accounts concerning Aughton Hall.
- 1685 Covenant between Viscount Castleton and his tenants re weekly payment of rent Aughton Hall
- 1683 Rental of the manor of Aughton
- 1721 Will of The Earl of Castleton showing he was the owner of The Manor of Aughton Estate. He divided his whole estate, including Aughton Manor to the Hon. Thomas Lumley Esq. (2nd son of Richard Late Earl of Scarborough).
- 1731 Survey of the lands owned by Sir Thomas Saunderson K.B. including Aughton Manor
- 1751 A fine is levied of the Manor of Aughton
- 1758 Rental of the manor of Aughton
- 1760/1 The manor was sold from the Earl of Scarborough to Mr Raper
- 1769 The manor is leased from Mr Raper to John Rigg & Mr Coppinger Esq.
- 1770 The Manor is leased for 1 year to Mr Flitcroft Esq, who then buys the Manor
- 1771 Aughton Manor is leased from for 1 year (names too blurred to read)
- 23rd June 1828 Richard Raimes Blanshard is born & lived in Aughton Hall, with his wife, Elizabeth Bland from Bubwith. He died on 11th May. It is possible that his parents, John Blanshard & Elizabeth Raimes lived at the Hall.
- 1831 Aughton Manor is owned by Henry Flitcroft
- 1832 Henry leases the Manor to Mr Edward Lambert for 14 years
- 1841 The manors title deeds are released to James Fletcher
- 1853 James sold Aughton Manor to his brother, Amoz James Fletcher Esq.
- 1895 Lilian Alexandra Dyson after the death of her husband, William Gladstone Dyson

- 1926 Barbara Evelyn Newshome (Spinster) & Joseph Edward Newshome (Farmer) & Thomas Henry Newshome (Gentleman) after the death of their Father, Thomas Henry Newshome Senior
- 1947 William Gladstone Dyson & Frederica Pauline Katherine Dyson. Left to their daughter, Miss Lilian Alexandra Dyson
- 1964 Thomas Johnson & Rose Evelyn Johnson of Monk Fryston for £4,200
- 1979 Edmund Richard William Warry Pears & Valerie Ann Pears for £50,000
- 1982 Gordon George Vincent & Betty Vincent for £85,000
- 1989 Mr & Mrs Dickinson
