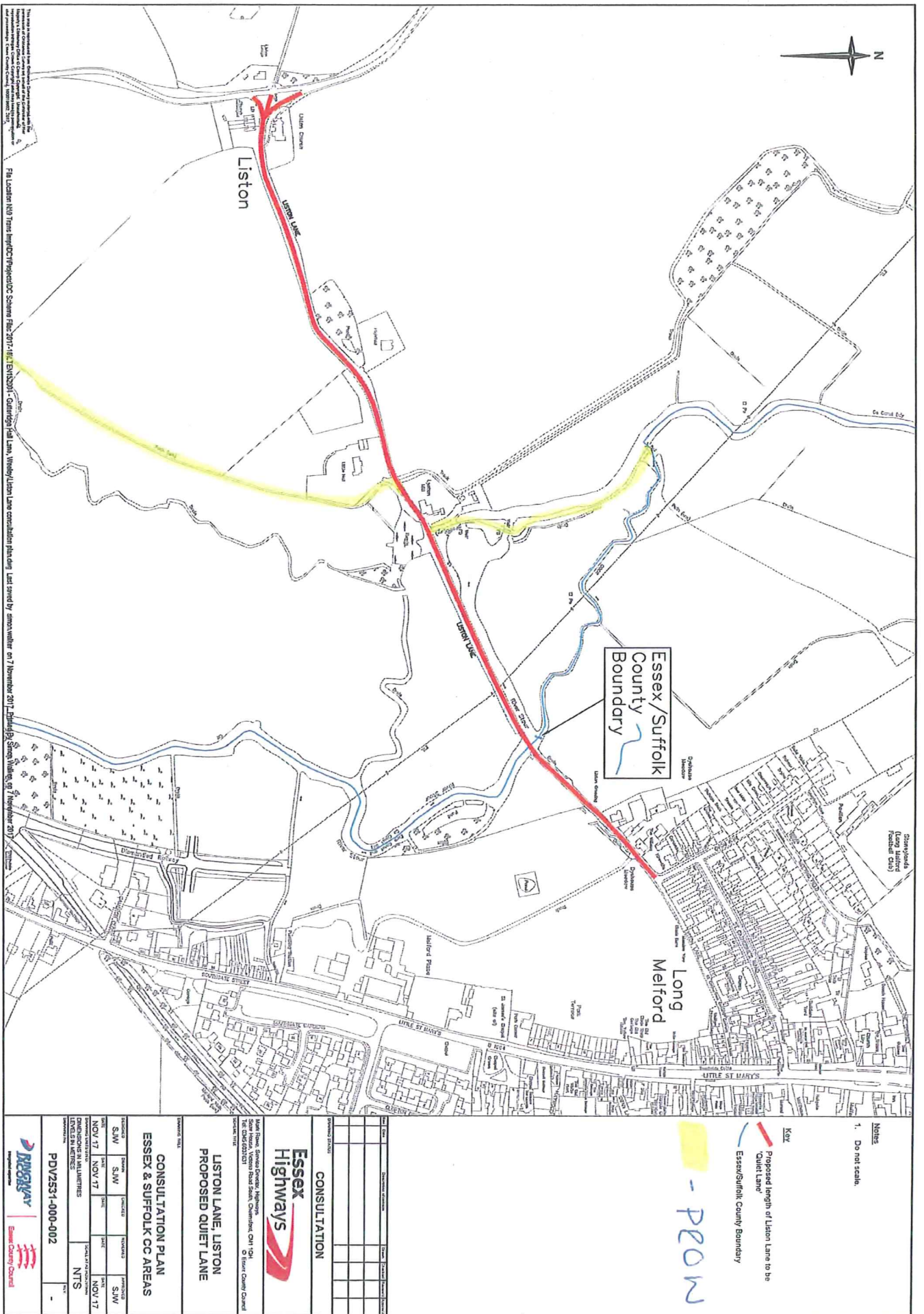

QUIET LANE – Liston Lane, Liston & Long Melford

Following a request from Foxearth and Liston Parish Council via the Braintree Local Highway Panel for the installation of a Quiet Lane in Liston Lane, we are writing to you to gain your views on the initial proposal. Essex Highways are proposing to work with Suffolk County Council with a view to designating the length of Liston Lane from its junction with New Road in Long Melford westwards to the junction at Liston Church.

Quiet Lanes are designated minor rural single track roads intended to highlight the needs of walkers, cyclists, horse riders and the mobility-impaired. They are designed to enable users to enjoy country lanes by encouraging car drivers to be more aware of their environment and the users they may encounter.

Quiet Lanes are a positive way of:

- providing a chance for people to walk, cycle and horse ride in a suitable environment;
- widening transport choice; and
- protecting the character and tranquillity of country lanes.

Please see the attached plan showing the proposed location of the Quiet Lane. This is achieved only through a small sign at each end of the route and encouraging increased use. No weight limits will be installed nor changes to the natural rural environment of the lane.

A public meeting has been booked at the Village Hall in Foxearth, the address is as shown below, on Tuesday 5th December between the hours of 5pm and 7pm.
