## **Covid update- Plan B measures to end**

Plan B measures in England are due to end by 26 January 2022. The Prime Minister Boris Johnson announced that the country will be reverting to Plan A from next week. This is possible due to how successful the uptake of booster vaccinations have been and how well people have followed Plan B measures in the last few weeks.

The main changes to Covid-19 measures include:

- Face coverings in public spaces will no longer be mandatory from 26 January 2022. Individuals are still encouraged to wear a face covering in crowded and enclosed places where they may come into contact with other people they do not normally meet.
- The Government is no longer asking people to work from home.
- Venues and events will no longer be required by law to use the NHS Covid Pass, although they can still be used on a voluntary basis.

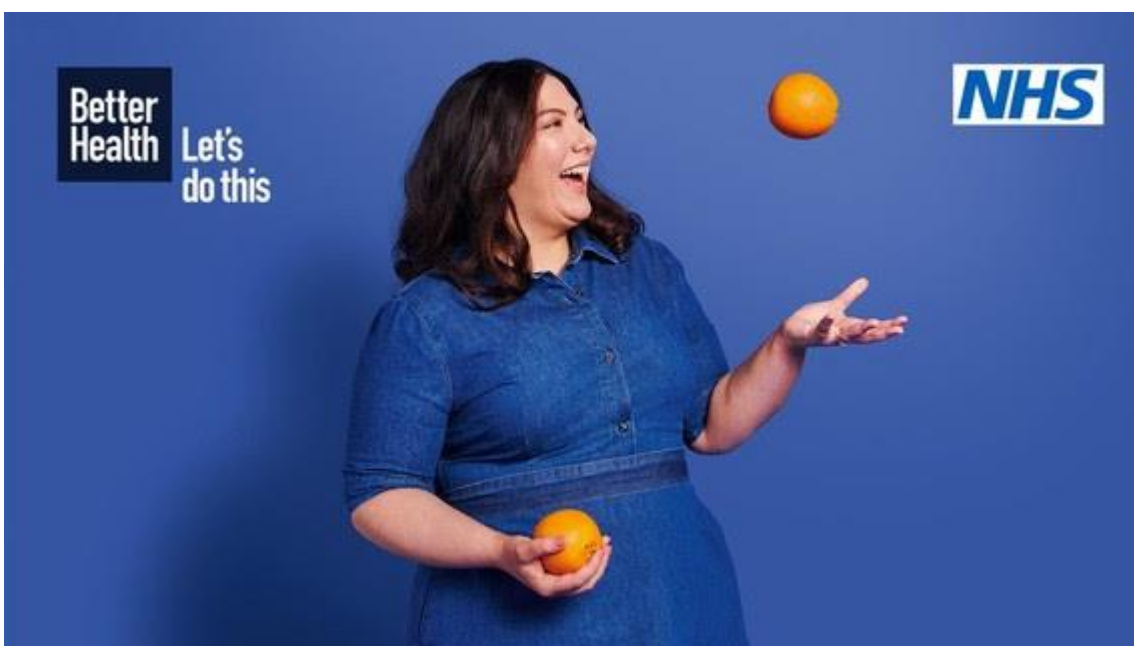

## Planning appeal dismissed over character harm and environmental concerns

The refusal of a proposed development of up to 90 homes in Black Notley, Braintree by Gladman Developments has been upheld by the Planning Inspectorate over concerns about the harm to the character and appearance of the countryside, as well as conflicts with national and local planning policies.

An application for the demolition of existing farm outbuildings and the erection of up to 90 dwellings on land off Brain Valley Avenue was submitted to our planning team in December 2020.

Over 200 objections were received during the public consultation period and the application was refused at a planning committee in September 2021 on the advice of officers.

We will continue to fight against unsuitable, unsustainable and poorly designed developments to protect the whole district, which is an important consideration reflected in our existing and emerging local plans.

As part of our Climate Change Strategy to be carbon neutral by 2030, we will also continue to work with developers to ensure new developments fit in with and enhance the natural environment, helping to reduce the carbon impact and improve biodiversity.

## Funding to prevent homelessness for vulnerable renters

The Government recently announced that additional funding will be made available to local authorities in 2021/22 to help vulnerable households with rent arrears to reduce the risk of them being evicted and becoming homeless.

The purpose of this one-off payment is to support low-income renters with **COVID-19 related rent arrears** to avoid eviction or find a new home where necessary in order to prevent homelessness, with local authorities able to target funding to those who need it most and help them get back on their feet.

Throughout the pandemic Braintree District Council have offered support to the most vulnerable households, and this additional funding will help those that are still struggling to get back on their feet as we continue to recover from the ongoing impact of COVID-19. As we enter the winter months the aim is to use this funding to help people most at risk of losing their home. Local authorities have to allocate the Tenant Hardship Grant Fund by the end of this financial year (March 2022).

## Get your Covid-19 vaccination!

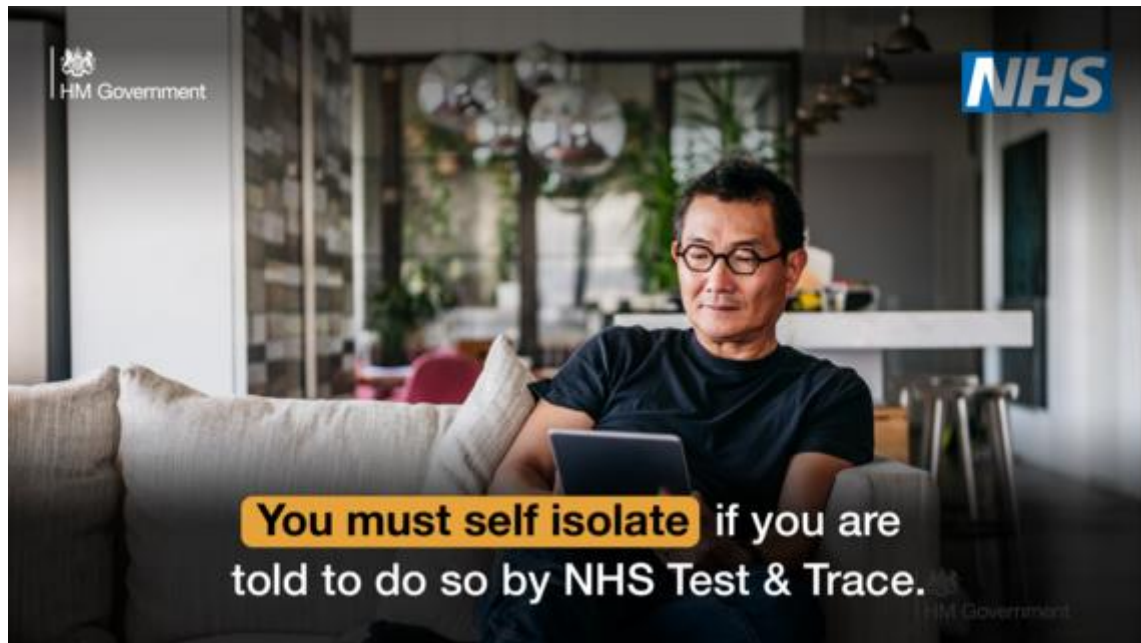


If you are not vaccinated you are about **8 times** more likely to be hospitalised with Covid-19. Make sure you are fully vaccinated by getting two vaccines and the booster.

The Covid-19 vaccine is the best protection for you and your loved ones against becoming very unwell and being admitted to hospital.



It is still a legal requirement for those with Covid-19 to self-isolate for ten days, with the option to end self-isolation after five full days following two negative lateral flow device (LFD) tests.

## Essex County Council's Recycling Centre Update





From **Monday 28 February 2022**, vans who are visiting an Essex Recycling centre are being asked to book a timeslot before visiting. Slots can be booked up to two weeks in advance [online](#).

The new system has been put in place to help reduce waiting times, decrease congestion and improve the customer experience at recycling centres.

The new booking system does not apply to cars who are able to visit as usual. Blue Badge holders will still be permitted to visit all recycling centres in a van with no prior booking required.

## WEEE recycling service continuing



After last year's successful trial, the scheme to collect unwanted small **Waste from Electrical and Electronic Equipment (WEEE)** items, is now set to continue.

The WEEE Recycling vehicle will be visiting the designated locations on a four-weekly cycle on Wednesdays.

In January 2020, when the scheme was introduced at various sites, more than 7,000 tonnes were collected. Residents dropped off the items at different drop-off locations which meant they did not go into the general household waste.

All electrical items contain chemicals, some of which can be hazardous if they are incorrectly disposed of and if not treated properly, they can be harmful to the environment and pose a health risk, as well as having an impact on climate change. The WEEE collected is recycled in the proper manner in order to pass the General Product Safety Regulations.

## Help for winter fuel costs



Temperatures are dropping and with rising energy prices, many households are worried about their heating bills.

Take a look at some of the benefits you might be entitled to this winter:

- [Winter Fuel Payment](#) - a tax-free benefit of up to £300 to pay for heating. People born on or before 5 May 1953 will qualify this year. The exact amount depends on your circumstances including your age, whether you live alone, get Pension Credit, or income-based Jobseeker's or Employment and Support Allowances.
- [Cold Weather Payment](#) - made during periods of very cold weather, to help pay for extra heating costs. The average temperature where you live must be recorded or forecast below 0°C for seven days in a row. You may be eligible if you are getting Pension Credit, Income Support, Jobseeker's Allowance or you receive Child Tax Credit that includes a disability element
- [Warm Home Discount Scheme](#) - helps low-income and vulnerable households with energy costs. Participating energy companies will be providing a discount of £140 on the electricity bill of certain customers, as well as discounts to a broader group of low-income customers.

**Help to Grow: Digital scheme launched**

The government's [Help to Grow: Digital](#) scheme is now open for applications. The scheme was designed to support smaller businesses in adopting digital technologies in order for them to be able to grow.

Businesses which are eligible are able to apply for discounts of up to £5,000 off the retail price of approved Digital Accounting and CRM software from leading technology suppliers.

Businesses are also able to access practical, specialised support and advice on how to choose the right technology for their business.

## Omicron Leisure and Hospitality Grant Scheme- still open

The Omicron Leisure and Hospitality grant scheme is still open until the **24 February 2022**. This grant aims to provide support to businesses that are experiencing difficulties because of the Omicron variant.

Businesses in the hospitality, leisure and accommodation sectors that provide in-person services are eligible for **one-off grants of up to £6,000** per premises.

## Flood Risk Resilience



All businesses in the UK are at risk of being affected by flooding even if they are not near a river or the sea. Flooding is the biggest issue which may cause disruption or damage to a business, and according to estimates flooding accounts for 33% of losses to property.

Businesses can sign up to flood warnings [online](#) to be made aware if there is likely to be a flood risk in their area.

There are also a number of other ways of being as prepared as possible for floods, including drawing up a flood plan or assigning a designated member of staff to deal with flood related issues.

**Working together to tackle anti-social behaviour**



We're pleased to be supporting Essex Police with the introduction of a new anti-drug spray in Braintree and Witham town centres - the first of its kind in Essex as part of their ongoing work to tackle anti-social behaviour.

They visited licensed premises and public venues throughout Braintree and Witham's town centres last weekend to coat surfaces that can often be used for recreational drug taking, such as those in bathrooms.

The clear substance coats the surface with a powerful bittering agent which reacts with any powdered substance. If the substance is then ingested, it will have a foul taste which can last several hours.

The initiative has been launched and funded by the Braintree District Community Safety Partnership, made up of us, Essex Police, Essex County Fire & Rescue Service and other services who are all committed to reducing the risk and impact of crime and hidden harm in the Braintree District.

The UK Health Security Agency and the NHS are reminding parents to ensure their children are up to date with the measles, mumps and rubella (MMR) vaccine, as well as all other routine childhood immunisations.

The NHS continued to provide these valuable routine vaccinations throughout the pandemic. Routine childhood vaccinations are key in protecting children from preventable diseases.

If parents are unsure if their child's immunisations are up to date they should in the first instance consult the child's Personal Health Record (Red Book), and if they have any further queries contact their GP.

## Support with rising energy costs



Last week the Chancellor Rishi Sunak announced a Council Tax Rebate of £150 for those whose properties fall in bands A to D to help with rising energy costs.

On top of this discount, it was announced that discretionary funding of £144 million will also be provided to support vulnerable people and individuals on low incomes that do not pay Council Tax, or that pay Council Tax for properties in Bands E-H.

We are awaiting more information from central government on how this will be administered for those in the Braintree district, and we will update you as and when we know more.

### **Essential Living Fund to support families**

For Essex residents in need of emergency support to help with essential living costs, they can apply for Essex County Council's Essential Living Fund. If they are eligible, they will be offered support such as vouchers for food and fuel, or high-quality pre-owned furniture from reputable charities as well as white goods.

The package seeks to help businesses affected by the pandemic, but who have been unable to benefit from existing support linked to business rates.

This relief is for businesses **outside** the retail, hospitality and leisure sectors.

## Save money on solar panels



Essex residents who own their own home or have permission from the landlord to install a solar PV system, as well as some businesses, can register now for [Solar Together](#).

The scheme aims to help solar panel buyers save money on installation and future energy bills. It offers lower prices than the open market and also pairs up residents with trusted suppliers.

Essex residents can register their interest online from 7 February 2022, simply providing information about the roof such as size and orientation.

From 4 April 2022 residents will be contacted with a personal recommendation, costs and specification for solar panel installation, and then residents have until 13 May 2022 to decide whether they wish to progress.

**More investment to strengthen our Planning Enforcement service**



At our [Full Council meeting](#) on Monday, our budget for 2022/23 was approved which will see significant investment into the district while also protecting front-line services.

Following feedback from residents and parish councils, we will be substantially strengthening our Planning Enforcement service with over £200,000 invested into additional staffing, along with a £150,000 working budget allocated from the Council's reserves.

This will enable more proactive monitoring and checking of planning compliance, and more robust enforcement where conditions are not being met.

## Old Rickstones Neighbourhood Centre granted planning permission to be demolished & revamped

This month our Planning Committee granted planning permission for plans to demolish the Rickstones Neighbourhood Centre in Witham, at the junction of Laburnum Way and Dorothy Sayers Drive.

The current buildings and public realm received little investment in recent years, resulting in the area having a 'run-down' appearance, alongside a high number of commercial units standing empty and having been boarded up.

The developers have been attempting to redevelop it since 2007. They withdrew their previous plans in 2018 and have now revived plans for the site which includes commercial units, 21 new flats, landscaping, gardens and a car park.

The commercial spaces will be for business, service and takeaway use.

## A budget set to support communities, enhance the environment and invest in economic growth and recovery



More investment to support our residents and businesses, enhancing the environment and economic growth are at the centre of our budget for 2022/23.

Our budget will see significant investment in services and infrastructure, whilst ensuring no cuts to existing services for residents.

To help protect and enhance services and help the district bounce back stronger as part of our [Bouncing Back Together plan](#), we will be investing into several key priorities that matter to residents and businesses, including:

- Further key priority projects as part of our ambitious investment strategy are to come to fruition utilising the New Homes Bonus (Halstead and Witham town centres, development of business cases on Malting's Lane community centre, Witham Enterprise Units by summer 2022)
- Over £200,000 invested into additional staffing for Planning Enforcement
- £141,000 to develop actions set out in our climate change strategy to address the issues and environmental sustainability
- Investment into creating a better connected network of high quality cycling and walking routes across the district as part of its cycling strategy



- Continuation of the Braintree District [Councillors' Community Grant Scheme](#) to provide additional funding support for local projects and initiatives
- £150,000 to support our commitment to play area refurbishments across the district
- £1.5m added to our current capital investment programme

Residents living in Essex could qualify for up to £10,000 of free funding for energy efficiency home improvements, including insulation, heating and hot water systems, solar panels and lighting.

Upgrading your home can reduce your energy bills, keep you warm and lower your carbon emissions.

Delivered by Essex County Council, the Green Homes Grant Local Authority Delivery scheme is for properties with a D, E, F or G Energy Performance Certificate rating (EPC).

To be eligible for this grant you should be a homeowner with a D-G EPC rating and a combined household annual income of below £30,000.

## **New facelift to Braintree District litter bins**



We are currently installing new brightly coloured litter bins at various lay-bys located on the A12, A120 and A131.

In the continuous effort to keep the district clean and tidy, and tackle the impact of litter on the environment, 57 brand new bins have been purchased and installed across the district, which have been match funded by WRAP.

In a new innovative approach 7 customised bins are being trialled that have a large single opening, which will allow people to dispose of their litter without having to leave their vehicle, helping to increase bin usage and decrease bags of rubbish being dumped.
