O65/2025 Councillors' old Gmail email accounts being ceased – update from Cllr M. Posen Cllr M. Posen is to look into migrating all gmail accounts over to .gov.uk before the September meeting

1066/2025 Local Government reorganisation - to discuss the possibility of joining with Suffolk rather than Essex

Cllr K. Holmes has spoken to neighbouring Parish Council who are, in principle, in favour of joining Suffolk CC The river makes it a natural boundary and could prove problematic. Changing the Essex Suffolk border is demanding. Cllr K. Holmes to contact Pentlow Parish Council to see if they would be interested in moving to Suffolk CC. Cllr K. Holmes' view is that it would be a big ask to move without other Parish Councils joining in on the move.

067/2025 Footpath update – Cllr K. Robson

Contractor has cut and made a good job cutting the footpaths in first week of June. Brook Hall Farm has bought more land and placed a hard-core track along a footpath. Cllr K. Robson has contacted ECC regarding this issue. Cllr K. Holmes is meeting with Jason from ECC PROW officer soon.

068/2025 Highway issues

• Speed Indicator Device (SID) – Update, traffic report and further actions – Cllr M. Posen Cllr M. Posen informed the meeting following the erection of the SID on 26th. May and circulated data from the SID from 26th. May to 7th. July '25 (6 weeks)

Key highlights of the traffic data are:

- Vehicle count in the period: 40,492
- Average daily vehicle count: 953
- Average speed of vehicles passing the SID: 27.7 mph
- Maximum speed passing the SID: 65 mph
- Percentage of vehicles exceeding the 30mph limit: **30%** (National average is 43%)
- Percentage of vehicles exceeding 35mph: **6%**

Whilst it is clear that a large proportion of vehicles are observing the speed limit, 30% broke the limit. This is actually a smaller percentage than the national average of 43% of vehicles exceeding a 30mph limit1. However, given the narrow pavements on one side of the road through Foxearth, and the lack of pavements on the other side, 30% of vehicles speeding is concerning, and the fact that a number of vehicles have passed through the village at speeds between 50mph and 65mph is very troubling.

Noting these figures, Councillors considered taking action on vehicle speed, which might include:

1) Supporting and encouraging villagers to reinstate the Community Speedwatch scheme.

- 2) Asking Essex Police to visit the village on a regular basis to conduct formal speed checks.
- 3) Trying to find a suitable location on private land at the other end of Foxearth, where a second pole could be erected, thus allowing the SID to be moved between the two sites from time to time, in order to try to slow and monitor traffic entering the village from the Rodbridge end.
