### 008/2020 District Councillors report – BDC Cllr I. Parker

BDC Cllr I. Parker supplied the following report

I would like to update you on:

- The examination of Section 1 of the draft Local Plan (Garden Communities) is currently taking place and is due to end on Thursday 30th January.
- BDC have recently published their corporate strategy for 2020 to 2024. This can be viewed on the Council's website.
- There is currently a consultation on Braintree Town Centre to include pedestrianisation. The consultation closes on 6th Feb. Details on the BDC website.
- Work on the regeneration project at Manor Street, Braintree is due to start in March 2020.
- A new "Visit Braintree District" tourism website will be launched this month.
- By the end of March 2020, we should have delivered a further 200 affordable dwellings in the District.
- We have set up a Climate Change working group. The areas of focus are Transport, Resources, Energy Use, Planning and Development, Council Assets, Natural Environment and Adapting to Climate Change.

#### 009/2020 Public Participation Session

The Chairman will invite questions and observations from members of the public present. A maximum time of 15 minutes will be allowed

- An accident has happened where a lady broke her ankle in Foxearth at a stile number 21 at the
  junction of footpaths 21/22/23. Cllr K. Robson to investigate this accident and will report it to Essex
  County Council.
- The War Memorial is still an ongoing issue.
- The village sign update is to have the branches cut back and a very gentle clean to keep the sign looking good.
- CBB aftercare following works undertaken. Rubbish / earth needs removing from the gulley's.



# 010/2020 Broadband update - Cllr M. Posen

No further update has been received since the last meeting. Works are continuing and will be completed by March 2020. But it seems unlikely to be completed by then. Cllr M. Posen will contact CBB regarding standard of works and a completition date. The disruptive of residents when the village is closed for CBB works and residents' access must be maintained.

Can the PC be more proactive in asking CBB for updates and completion date, which includes a programme of works whether poles will be used or to go underground?

Cllr M. Posen proposed writing to ECC Cllr D. Finch to inform him of the resident's views of ECC Highways managing this issue.

### 011/2020 Footpath update – Cllr K. Robson

Bradfield Farm signs have fallen. Following the Public Participation Session Cllr K. Robson has taken all residents' concerns onboard.

ECC Cutting Service Agreement can be entered into. Cllr K. Robson to enquire and to obtain more detail from ECC.

Cllr T. Clayton informed the meeting that on the issue of the Permissive path in Liston he has received an acknowledgment of the application. This is still a lengthy process to undertake.
