
Voluntary Work for National Trust

Friends of Osterley Park

Osterley Park is a unique country estate, hidden in a suburban location close to the Great West Road. The Tudor house, built for Sir Thomas Gresham, was transformed in the 1760s into a neoclassical mansion by the architect Robert Adam for the banker Robert Child. The House passed by marriage to the 5th Earl of Jersey.

In 1949, the 9th Earl gave the House and the Parkland to the National Trust and was initially leased to the V&A Museum.

In 1991 the Trust took over running the property and opened to the public. At this time the Friends of Osterley Park was formed to build on the strong affection which had developed locally for the Property and to provide practical and financial help. The Friends have, since 1991, given over £100,000 for various projects.

We pay annually for:-

- Maintenance of self-drive Battery vehicles used by less mobile visitors
- Materials for the volunteer gardeners growing flowers for displays in the House.
- Maintenance of the Courtesy Buggy which shuttles between the car park and the House.

In 2017 we purchased a new 8 seat buggy plus wheelchairs for use in the house and grounds.

We also fund specific items at the request of the Property.

Recent items for the house include the bases for the Chinese Parade Jars in the Long Gallery; the materials for the benches for visitors in the House; floodlights for demonstrations in the house during Conservation in Action week; room signs.

For outdoors we purchased a boat, a rotavator (by Ferrari!), a mulcher, a bat detector and other equipment for the Estate, and a craft cart.
