Matters arising from April 2024

Calendar for 2025 - The deadline for calendar photographs is September. Currently we do not have enough entries. We will remind our Social Media users to submit suitable photographs and also as a committee we should prompt individual photographers if we see suitable images posted on our Facebook site. Greeting Cards - We will run a poll on Social Media to see if there is an appetite for Rising Sun Greeting Cards. (**AP2**) We will also look at the possibility of a printer providing us with a smaller print run than the current quote we have received. (**AP3**)

Voluntary Organisations Development Agency (VODA) Meeting update - Amanda Williams and Claire Partleton met with Rebecca Williams who is the Governance expert at VODA to look at what basic policies and procedures the Friends group should have in place. Big Green Week 8th - 16th June 2024

The Great Big Green Week is the UK's biggest ever celebration of community action to tackle climate change and protect nature. In 2024, Great Big Green Week will take place between 8th and 16th June. This year's theme is "Lets swap together". The Committee agreed that the Friends Groups should take part in this year's event. The Friends of the Rising Sun will:

- Arrange a Litter Pick on Saturday 8th June (AP6)
- Arrange to Swap plants from the Backyard Allotment week commencing 8th June (AP7)

Update from North Tyneside Council (NTC): Nothing to be reported this month.

Other Business:

- Committee agreed the purchase of compost for the Backyard Allotment for the growing of new plants.
- Committee agreed to purchase Ear Defenders for use with the Shredder Machine (AP8)
- Due to Ward Boundary Changes the Park is now totally in the Battle Ward. The Committee agreed that Claire should invite the new Councillor to join us on a Litter Pick and also provide them with information about the Friends of the Rising Sun Group (AP9)
- At the meeting with VODA they suggested the Group should set a yearly budget at the start of the financial year. This will be discussed at next month's meeting. (AP10)
