Great Horwood Parish Council Minutes of an Ordinary Parish Council Meeting held on 8th December 2014 at 7.30pm in the Village Hall, Great Horwood.

To receive apologies for absence

All Councillors were present.

2. To confirm the Minutes of the Meeting held on 10th November 2014

No amendments were made.

3. To receive declarations of interest

No declarations of interest were received.

4. To consider matters arising from the Minutes of the last meeting

- Published bus timetables have been amended to include information on concessionary passes and sent to BCC.
- A response was submitted to AVDCs consultation on the Vale of Aylesbury Local Plan arguing that Great Horwood has been wrongly classified as a large village in the Settlement Hierarchy published by AVDC in September 2012.

5. Public Participation Period

No issues were raised.

Planning Issues

6.1. Councillors were provided with an updated Planning Report which was ratified at the meeting. No new applications had been received but two applications had been determined. The planning report is attached to and forms part of these minutes.

7. Report from the Recreation Committee

- There are a couple of minor items which need repair over the Christmas break but generally the Rec is in good order.
- Bucks University Technical College are still being pursued to lay some paving but nothing has been heard.

8. Footpaths Report

There is nothing to report this month.

9. Neighbourhood Plan

The Neighbourhood Plan hearing was held on Thursday 27th November and lasted 5 hours. All developers opposing the plan attended and responded to questions put by the examiner as did 3 residents who also oppose the plan. The examiner was planning on reporting back in December but subsequently a letter has been received in which he invites comments as to whether he should take into consideration a study which was undertaken for the, now defunct, Vale of Aylesbury Plan.

The NPT believe it is appropriate for the examiner to use this study as it is evidence that is still valid. Comments are to be received by AVDC no later than Wednesday 17th December and the NPT consultant is working on a response.

Cllr Gilbey also thanked Gill Wood who organised the logistics within the village hall for the hearing.

10. <u>Chairman's statement to respond to an untrue submission in response to the publicity period of the Great Horwood</u> Neighbourhood Plan and published on the AVDC website.

Cllr Gilbey has been made aware of a submission that was made to AVDC during the public period of consultation on the Neighbourhood Plan. In response to this he issued the following statement.

During the AVDC publicity period for the Great Horwood Neighbourhood Plan a submission was posted on the AVDC website apparently from somebody called David Timms which contained the following sentence.

"I also understand, that Mr Gilbey, sold his back garden in Willow Road for a single dwelling to be developed. It is interesting to note this, given if it benefits him he is happy to accept development."

This is an untrue statement as my wife and I actually opposed the planning applications for the property that is referred to and which is now known as 1A Willow Road. In fact, the land in question previously formed part of the

garden of 12 Little Horwood Road and when this property was sold to the current owners in 2002 the end of the garden had been fenced off and its ownership was retained by the descendants of the previous owner. The access to this area of land was obtained by the purchase from AVDC of the strip of land fronting Willow Road.

All of this information is easily verifiable by AVDC from its archives and will confirm that as the owners of 14 Little Horwood Road, my wife and I had no benefit from the development, in fact quite the reverse.

11. Traveller Site in Nash and meeting with AVDC

On 26th November Cllrs Gilbey and Scholtens attended a meeting at the offices of AVDC to discuss the future of the traveller site on the edge of the Parish boundary towards Nash. The following personnel were present.

Neil Blake, Leader of AVDC, Carole Paternoster, Cabinet member for Strategic Planning Sir Beville Stanier Tracey Aldworth Director Susan Kitchen Manager Development Management Andy Kirkham Forward Plans manager Three representatives from Nash Parish Council

Neil Blake confirmed AVDC are no further with finding traveller sites than when temporary permission was granted in November 2011 and the expectation is that further temporary planning permission will be granted, or even permanent permission.

Cllr Margerrison asked if the PC could launch a legal bid if permanent planning permission was given and it was agreed that this was a possibility but would incur a great deal of expense.

12. Devolved Services from BCC

Further information has been provided from BCC regarding devolved services and it transpires that the budget being provided by BCC would not cover the contractor's costs to carry out the works. Additional clarification is also needed on how the calculations per Parish have been carried out.

Therefore it was agreed that the PC would not participate in any devolved services for the next financial year and the Clerk would write back to BCC confirming this. A decision on taking on responsibility for the services in the following years would be a question for the new Parish Council to be elected in May 2015.

13. Maintenance Contract for MVAS

A contract has been sent to the Parish Council for maintenance. The total annual cost is £187.73 and covers maintenance but not repairs. Two thirds of the cost is in the budget but the annual cost has increased since the signs were installed. Councillors agreed to pay this and discussion about increasing the budget for the new financial year would be discussed under item 16.

14. Defibrillators

Cllr Mayne had met with the project leader from Buckingham who provided lots of useful information. Cllr Mayne explained the costs involved and it was agreed she should order a defibrillator and get the process started for getting it installed.

15. Report from the Village Walk

Cllr Mayne met with TfB to talk about highway and transport issues within the village.

- The damaged sign will be replaced.
- White lines will not be repainted until at least Spring 2015.
- The repair of the path near the Rec is classed as non-urgent but will be completed eventually.

At this point Sir Beville Stanier, District Cllr, joined the meeting. Cllr Gilbey thanked him for arranging the meeting with Neil Blake as discussed in item 11. Sir Beville reiterated the views of Cllrs Gilbey and Scholtens that there was very little AVDC could do.

16. Second Draft of Budget 2015/2016

Prior to the meeting the Clerk circulated the second draft of the budget for Councillors to consider. A small number of amendments had been made. After discussion it was agreed to increase the budgeted amount for the MVAS maintenance to £700 (£200 for the maintenance contract and £500 for emergencies). The Clerk will make this change and will submit the precept request in January unless further changes emerge.

17. Vodafone Open Signal

The deadline for this has now passed so will be removed from the agenda.
