Horwode Pece Management Committee - Report to Parish Council March 2019

As explained last month, our major activity over the winter months is the weekly Rec. checks.

Over the last four weeks, since the Feb. report, we have seen further damage down the Rec. This takes two forms; what appears to be damage by an animal gnawing at the cross beams of the shelter and some of the seats and benches, and a large section of the teenage surround that has been deliberately kicked off.

First then, the animal damage: A man with a large dog, possibly a Rottweiler, was seen down the Rec. The dog was not on a lead and was seen gnawing at the shelter woodwork. The man was ignoring what the dog was doing, more interested in his mobile phone. Once informed, I went down the Rec. to inspect the damage; a number of the horizontal bars/seats have been damaged with large sections of woodwork torn from these cross members. As temporary remedial work the damaged areas have been sprayed with Grannick's 'Bitter Apple' – a treatment to discourage dogs and other animals from gnawing patio furniture etc. We will watch developments with this.

I have searched the internet for possible solutions and have found a recipe for a bulk solution treatment for woodwork that discourages animal damage – it involves Acetic acid, Citric acid and Cayenne pepper as ingredients. I would like to buy a bulk purchase of these ingredients, mix the formulation and then treat all the woodwork down the Rec. This will cost around £17.

To keep people informed, Cathy Holland has offered to prepare an article for Focus and Jane Holland has put it on the Great Horwood Facebook web-site.

The second damage area of damage, the kicked off log-surround at the zip-wire side of the teenage area, is more difficult to repair. In kicking off the log-surround three of the posts that fix them into the ground have been damaged and these will need to be removed and replaced with new posts. So, this becomes a job for the Spring working party. As a temporary solution, the damaged log-surround timbers have been removed and lay at ground level. As such they are not a safety hazard and can remain there until the Spring working party.

Last month, we reported on an alternative 'loose fill' to the woodchip for use down the Rec. The alternative - granulated, recycled, tyre rubber, costs £75 per tonne, plus delivery and VAT. We proposed to first replace the woodchip in the toddler area and aimed to do this as part of the Spring working party; at 147m2 and a depth of 300mm, this would require 15 tonnes – giving a cost of £1,135 + delivery +VAT. Delivery is likely to cost £210, which is the cost of a lorry load up to 20 tonne. Do we have the Parish Councils permission to proceed with this?

The Scouts have offered to help with moving the woodchip as part of their Community badge, hopefully at the Spring Working Party.

Any woodchip removed from the Toddler area will be used to top up the Teenage area, thus replacing the woodchip in the Teenage area can be delayed until next year. The Teenage area is larger, estimated at 250m2. For this area at 300mm depth, we would need 25 tonnes – giving a cost of £1,875 + delivery + VAT. Delivery would now take two lorry loads, £420. So, the costs for replacing the 'loose fill' for the Teenage area would need to be included in next year's budget, plus we must not forget installation costs.
