



# Great Horwood Parish Council

Minutes of an Ordinary Parish Council held on 10<sup>th</sup> December 2018 at 7.30pm in the Village Hall, Great Horwood.

## Great Horwood Parish Council

1.	<b>To receive apologies for absence</b> Apologies were received from Dist. Cllr Sir Beville Stanier
2.	<b>To receive declarations of interest</b> • None
3.	<b>Confirmation of the Minutes of the Parish Council meeting held on 12<sup>th</sup> November 2018</b> • The Minutes were passed without amendment.
4.	<b>To consider matters arising from the Minutes of the last meeting</b> (not otherwise included in the agenda) Item 12 • Request to change the speed limit on Nash Road. Transport for Bucks (TfB) does not have the budget to do this and the Local Area Technician does not envisage a time when such a reduction would be approved due to low density of properties even with the new development. He suggested we approach Aylesbury Vale District Council (AVDC) to see whether a reduction in the speed limit is required by the terms of the planning application. • The B4033 is due to be repaired between 10 <sup>th</sup> and 14 <sup>th</sup> December 2018. Item 16 • Planning permission has still not been granted for the new fully accessible front entrance to the village hall but the replacement of the roof is planned to start in the new year. Item 18 • A suitable lamp post could not be found in the village for an electric car charging point. Bucks County Council (BCC) were unwilling to consider the lamp post on the corner of School End.

6.	<b>Public Participation</b> • a member of the public asked whether the Land South of Little Horwood Road Construction Management scheme had been amended to prohibit construction traffic using Little Horwood Road. The Clerk was asked to chase this up. ( <b>Action Clerk</b> ) • a member of the public asked if the deer carcass on Pilch Lane could be removed. ( <b>Action Clerk</b> ) • a member of the public thanked the Parish Council for the Battle's Over celebration and Focus for the memorable colour centrefold of the event. • a member of the public asked whether the MVAS could be moved further down Nash Road. Mr Mick Wood was asked to research a possible site and the Clerk was asked to research a quote for a new ground screw. ( <b>Action Clerk</b> )
7.	<b>To consider the GHPC Budget for the financial year 2019/2020</b> • The draft budget for 2019/2020 was discussed. • It was resolved: a). to use reserves to pay for the training of a new Parish Clerk. b). to reduce the Horwode Pece budget request from £6220 to £3220 as there were sufficient funds in the Horwode Pece account to cover the proposed budget for 2019/2020. As a new surface would be required earlier than expected c2021, a wood chip reserve was included in this budget. • It was resolved to approve the budget and request a precept of £29, 202. 00. The increase from £28500 (2018/2019 budget) will be funded from the council tax of 10 extra households in the village and will not require a rise in council tax.

Anyone using it should be wary as some of the sleepers are loose or have holes in them. He is not aware of any further problems regarding the Parish's footpaths or its bridle-way. b). to update progress on footpath gates It was decided that Cllrs CC & JH would walk to the stile at Bywater meadows to see whether it was a candidate for replacement. ## Horwode Pece Management Committee - Report to Parish Council December 2018

The major items for the Recreation Trust and the Rec. Management Committee in November were the Firework Event (a great success) and the working party, which was held over the weekend of 17th/18th November. It is sad to say that for this working party, only members of the Rec. management committee turned up. We will look to advertise it more widely for the Spring, after all, it is the villages Rec.

Still, many jobs were completed to keep it in good order; the security notices and cameras have been installed above the shelter, pointing to oversee both play areas. Also, most of the graffiti has been cleaned from the shelter woodwork, some further repair work has been undertaken, plus remedial maintenance where required. The woodchip has been raked level for both the teenage and toddler play areas and the depth of the woodchip cushion-fall measured – it is just on the 300mm required by RoSPA, some 100mm below the maximum level - but not sufficiently down to take a full delivery of new Woodchip from Giffords. We will monitor this level and inform the Parish Council should we need to buy more, possibly a half-load. Meanwhile, we are investigating alternative, more durable, safety materials – granulated, recycled, tyre rubber - but believe these to be much more expensive on first installation, again, we will report back to the Parish Council.

Overall, the Rec. looks in good condition for the winter months.

For next season, we will need to:

1. Replace the wooden posts, supporting the earth banks for the tunnel – part of the toddler play area.
2. Install some large (200mm) coach-bolt fixings to the balancing beams (the gaps are larger than 8mm, a risk of finger entrapment for the younger children)
3. Replace the wood surround to both the areas – our major project next year.
4. Fill in cracks within the ground that remain following the dry summer – this was the one item that could not be completed in the Autumn Working Party, because of the few helpers who turned up. However, this is not a safety critical item and can be complete as part of the Spring Working Party.

A proposed budget for 2019-20 was submitted to the Parish Council of £6,220; this was prepared to cover running costs, contingency maintenance costs – mainly a top-up to the Woodchip safety cushionfall - and our anticipated costs to replace the log-surround of both the Toddler and Teenage areas. I understand from the Parish Clerk that our agreed budget is approximately half of that requested, £3,220; this will only cover our running costs and expected planned maintenance.

So, the major question is 'How much will it cost to replace the log surrounds for both the toddler and teenage areas?' As stated last month our estimate material costs are: ... using old railway sleepers, £2,900+VAT. ... using composite plastic sleepers (more durable), £18,900+VAT. or ... soil banking + grass, £2,500+VAT. My estimate of labour costs is £6,750. In total, replacing the log-surrounds could cost between £9,250 - £25,650.

I understand, based on the budget agreed by the Parish Council, that we may use up to £8,500 + VAT, from the 'Reserve fund' , until March 2020, to undertake this replacement of the log-surrounds.

I will keep you informed of any formal quotes for this work; we will not proceed without formal Parish Council approval.
