Minutes of an Ordinary Parish Council Meeting held on 10th April 2017 at 7.30pm in the Village Hall, Great Horwood.

Present: Cllr John Gilbey (JWG) Acting Chairman, Cllr N Heywood (NH), Cllr Jane Holland (JH), Cllr John Huskinson (JRH), Cllr Angela Mayne (AM), Mandy Cliffe (Clerk), County Cllr John Chilver, Dist. Cllr Sir Beville Stanier and 5 members of the public.

To receive apologies for absence Apologies were received from Cllr Mary Saunders. Cllr Heywood advised that he would be late arriving at the meeting. 2. To receive declarations of interest No new declarations were made. 3. Confirmation of the Minutes of the Parish Council Meeting held on 13th March 2017 The Minutes were approved without amendment. 4. To consider matters arising from the Minutes of the last meeting not otherwise included on the agenda There has been no response to the Parish Councillor vacancy. The sunken drain on the A421 near the Thornborough turn is still giving cause for concern as the bollards have been moved to the side of the road and there was no warning of the hazard. The Clerk was asked to contact Transport for Bucks (TfB) to check the progress of the repair. (Action Clerk) 12. Cllr JWG advised that there would be no response to the letter sent to the Secretary of State for Communities and Local Government (an acknowledgement has been received) on proposals for modernising local Government as no announcements would be made 16b. The Clerk was asked about progress on the repair to the village sign. As no response has been received from the carpenter, she was asked to follow this up. (Action Clerk) 5. **Public Participation Period** Cllr Chilver asked whether the flashing school sign and broken hidden dip sign had been repaired. The Clerk reported that the school sign had been repaired and then become unserviceable again. Bucks County Council (BCC) had been asked to look at it and as far as we can tell this has been successful. The Hidden dip sign on the A421 junction with Pilch Lane was reported twice. TfB are aware of the problem and it will be attended to on a priority basis. Mrs Gill Wood asked that the contractor be advised of the problem of grass being left on the pavements after mowing. The Clerk will speak to him. (Action Clerk) 6. **Horwode Pece Management Committee Report** The Management Committee Report is attached to these Minutes. It was noted that chippings had been over ordered this time and that too large a digger had been used to move the material, resulting in soft turf being damaged. Lessons had been learned. 7. **Footpaths Report** a. Footpath Monitor Mr Robert Deuchar (RD) reported: "All the Parish's footpaths have been pruned between mid-February and 20 March 2017. I did not find any major problems". The Clerk reported that she has had no response from BCC about the new footpath gate. Additionally, Dist. Cllr Sue Renshell had offered to provide a gate under the "donate a gate" scheme in memory of her mother. Robert Deuchar has identified a possible location on Footpath 6 for this gate and the Clerk was asked to contact the land owner. (Action Clerk) 8. Roads Report No roadworks have been reported in the local area. The Clerk reported that the flashing school sign had been causing problems again as already discussed in item 5. 9. **Planning Report** Councillors were provided with a Planning Report which was ratified. The Planning Committee resolved not to object to application 17/00874/APP (The Retreat). The clerk was asked to send a response on behalf of the Planning Committee to 16/03132/ADP (Winslow station car park). (Action Clerk) 10. Issues arising from the Planning Report Cllr JWG reported that he had contacted AVDC Assistant Director Mr Will Rysdale in respect of the expired dates and late determination of planning applications. Mr Rysdale's response is attached to these Minutes. The Clerk was asked to write to Mr Rysdale for further information. (Action Clerk) 11. To receive reports from Cllr JWG summarised events of a meeting he attended of the Parishes Liaison Meeting on 22nd March. The Minutes of the meeting have already been circulated. 12. To consider traffic in School Lane

Cllr Holland reported that her contact with the Police Commissioner had been unproductive, however, she was continuing to pursue it. Cllr JHR advised that the school was working to discourage parents from entering School Lane. Mrs Angela Gunn has written to local MP John Bercow.

Horwode Pece Management Committee - Report to Parish Council April 2017

The major item this month is the delivery of the woodchip to top up the play areas. Last month an order for 80 cu-metres of 'Cushion Fall' woodchip has been placed with Giffords. The proforma invoice was paid by the Parish Clerk and I contacted David Spooner (Digger Dave) confirming the delivery date to be the 30th March, so we were all set to go.

The woodchip was delivered on the 30th, with Jane Holland, Mike Hobday and Steve Brigden agreeing to be down the Rec. to meet the delivery lorry (I was away on business). Originally planned to arrive circa 9am, it did not finally arrive until after 11.40am!

Here is Steve Brigden's commentary. 'Firstly, thanks to Jane and Mike for turning up promptly to welcome the truck. Dave the digger was in place, too, from 08:00. Mike stayed for the handover at 08.50, when I arrived (shortly after Jane had to go). Finally, we got through on the phone to Giffords. 09:35 - the truck was just leaving Birmingham. ETA 11:30! I left. Dave the Digger left sometime later. I returned at 11:20, spoke with the driver who was twenty minutes away. 11:40 - a 16 ton truck with 12 metre trailer arrives with 80 cubic feet of woodchip. The tarp would not be enough. He tipped, then, half load on and half load off of his truck, he is stuck in the mud. No forward movement, no backward movement, only down. Digger Dave is now busy elsewhere but will return tomorrow at 08.00. Fifty minutes later, more tarp, shovels, rakes and man-power (they were all male) the truck moves. The rest of the load is lowered onto the spare tarp; big sigh of relief. Moments later the second large trailer is hauled in and tipped on the second pile...on the gate...on the hard standing and almost onto the road. There was so much, there was no containing it. The driver did his best.'

This gives you an idea of the work our intrepid three were overseeing and involved in. At 08.00 on the 1st, David Spooner with tipper truck moved this heap of woodchip and spread it to all play areas – it filled them, bulging – all the play areas had a good covering - and still there was some left over; next time – probably in two years' time – we must consider ordering less.

I visited at the weekend, the grass areas around the teenage and toddler play areas has some deep furrows – left by Digger Dave's dump truck in the water logged soil. The ground by the gate has a covering of chippings, that will need a working party with brooms, rakes, shovels and barrows to move it; a task for the Spring working party. Some work has started; thanks to Jane Holland and Steve Brigden.

We believe it is worth buying some mixed gravel to mix with the soil that will be lifted, plus a generous handful of woodchip, which can be used to fill the furrows and should also improve drainage. This material can be used to fill the many furrows created by the digger so that they do not scar the Recreation ground for the rest of the year.

Some of the excess wood chippings will also be used as mulch, under the roses and also can be spread alongside the path under the hedge-line. Other items of maintenance for this spring working party include: installation of new goal nets when the old ones finally fail, replacement of some plastic caps on items of equipment, fixing fall-matting and infilling with top-soil around the zip-wire and installing new posts for the Rec. noticeboard, as reported last month.

I have received from the Parish Clerk the Asset Register and will update this to reflect the current equipment and condition.
