Mr Robert Deuchar reported that<ul style="list-style-type: none">• The landowner of FP 6's one remaining stile does not wish to have a replacement metal pedestrian gate.• The Parish's one bridleway has been mown and brambles trimmed by Bucks CC in early November).b). Mr Deuchar and councillors will identify other gates for possible replacement. |
| 8. | Roads report <ul style="list-style-type: none">a). the latest reported roadworks were:<ul style="list-style-type: none">• Curb repairs on Spring Lane between 13th - 17th November outside number 1b and by Wigwell Gardens.• BT are working at the bottom of Great Horwood Road until 23rd November with limited road incursion.• Church Street in Little Horwood will be closed from 15th January to 26th January 2018 between 09.30 & 15.30 for those using that direction to bypass Winslow.• Buckingham Road, Winslow will be closed at a date to be notified between 1st January and 9th March 2018, between the hours of 09:30 and 15:30. The road will not be closed for the whole period. GHPC has asked Bucks County Council to try to make sure the road is opened by 15.00 but is awaiting confirmation.• Pot hole repairs in Willow Road have been completed and the large one in Singleborough Lane has been filled.b). Any comments the PC wish to make will necessitate careful consideration.b). In view of the above, it was resolved to set up a subcommittee to prepare any comments for approval at the December PC meeting. |

**HORWODE PECE MANAGEMENT COMMITTEE
REPORT TO PARISH COUNCIL
NOVEMBER 2017**

The major activity for the Management Committee in October was to organise the Autumn working party to undertake any urgent repairs to equipment and any other maintenance to the hedgerows, fences, groundworks etc. This was undertaken over a long weekend from 27th – 30th October. The main work was to repair the ramp to the toddler area. Thanks to the six people who helped over this long weekend, a total of 40 man-hours of work.

If you remember, in the September report, I reported damage due to rot of the toddler area ramp and surround. The ramp to the toddler play area had collapsed. Some temporary repairs were undertaken in September but then it broke / collapsed again in a different location and I decided to remove all of the structure that was unsafe, but left some of the woodwork and treads that were safe, level with the ground.

A new ramp has been constructed and installed. It is made from 'treated' woodwork – with a guaranteed life of 10 years, although if kept dry should last longer. The supports for the ramp have been built onto a series of stone bases (thanks to Jane Holland for finding a source where we could collect this stone for free – it saved us buying it) that will keep the woodwork off the clay sub-soil. Also, the lead-in to the ramp which must be buried part in the ground has been laid as paving on a brick base, so again will not rot. Particular thanks to Mike Hobday for providing the paving slabs and helping to lay them. Thanks also to Mike and Steve Brigden for their help with the construction of the ramp. The cost for this repair to the ramp was a little under £100, thanks to the stone and paving provided for free; my earlier estimate to the PC for this work had been £140.

While re-building the ramp, others helped with pruning the hedges back, racking the woodchip level and checking the general condition of the Rec. Thanks to Jane Holland and Nigel Heywood for this.

Overall, the working party was a great success. The ramp should be secure and safe for another 10 years. Still, not all of the required maintenance could be completed. While, undertaking the repair to the toddler area it was noted that part of the wood surround to this area had been kicked off, some further post timbers will need to be purchased and installed. Also, additional post fixings are required for the surround to the teenage area, both of which should be repaired over the winter season.

The next event to be organised down the Rec. is the Trust's firework display, on the 4th Nov. This has now happened and I understand it was a great success, but I leave it to Jane Holland to report this as she organised the event.

For the Parish Council diary: 'Picnic on the Pece' is planned for the 10th June, with 'Giocoso' playing for us this year.
