Minutes of an Ordinary Parish Council Meeting held on 13th July 2015 at 7.30pm in the Village Hall, Great Horwood.

Present:

To receive apologies for absence

All Councillors were present.

2. To confirm the Minutes of the Meeting held on 8th June 2015

No amendments were made.

3. To receive declarations of interest

None were received.

4. To consider matters arising from the Minutes of the last meeting

- Thanks went to Mick Wood and Duncan Trigg for taking over the responsibility of moving the MVAS.
- A grass cutting contractor has been appointed at Horwode Pece and all is going well.
- The planters need some maintenance. JS has cleared around the one on the Singleborough Road and JH has been looking after the one on the Little Horwood Road but the other three need attention.
- Hedges on The Green have been cut. This was carried out by JS and JH.
- The NPT email account still needs to be closed.
- A letter was sent to the owner of the old mill next to Horwode Pece but no response has been received.

5. Public Participation Period

Mick Wood gave an update on the MVAS. He and Duncan Trigg have been moving it between sites in order to collect data which can be analysed meaningfully. He has also spoken to TVP who will consider siting Traffic Officers in sites that have a specific problem. Data will continue to be collected over the next few weeks and an update will be given at the next meeting.

A problem had been highlighted where the grass cutting teams had damaged the fixing for the MVAS in Little Horwood Road. It was suggested a permanent pole could be installed in order to stop this happening and the Clerk will investigate the cost.

6. Planning Issues

6.1. Councillors were provided with an updated Planning Report which was ratified at the meeting. Eleven new applications had been received and one application had been determined. The planning report is attached to and forms part of these minutes.

JS was asked what was happening with the two large planning applications and he agreed to contact AVDC in order to ask for an update.

Planning Application 15/02233/APP – Nash Park – was discussed. After discussion it was agreed the PC would object to it, JS would draft an objection letter and circulate it among Councillors for comments.

7. Report from the Recreation Committee

 No report had been received so JH gave a short update of the meetings she had attended. The Recreation Committee had decided to purchase monkey bars with the reserves ring-fenced by the Parish Council.

8. Footpaths Report

Robert Deuchar has pruned the Parish's footpaths and is not aware of any problems.

9. Report from the NBPPC Meeting held on 10th June

MS attended this meeting and a short update was given.

10. Report from the LAF Meeting held on 17th June

JWG and JG attended. Some members of the GH&S Youth Club attended as a grant was being made to the Club to the value of £2000. The Sentinel Speed Camera Device was also discussed and the Transport Committee gave details of a small budget available for road repairs for minor roads.

11. Report from the Plunkett Workshop

JH attended this workshop and explained how useful it was as it demonstrated how the Plunkett Foundation can help many different projects and how a village community needs to be engaged. Her conclusion was that she wanted to make the village a more vibrant place by increasing the number of community events.

12. Parish Plan 2016

JS, JRH and David Saunders met to assess the Parish Plan from 2006 and therefore what was required for the Parish Plan 2016. Work is ongoing with the revision of the Action Plan from 2010, where they identified what actions had been achieved, which had been parked and what was needed in the future.

JWG suggested that JH's comments on a Community Shop were incorporated into the Action Plan.

13. Digital Communication

Since the last meeting a number of emails had been circulated regarding a new website. It was agreed that the way forward was to improve the current website rather than build a new one, and that contributors to the site should be asked to provide the information to update their areas. JWG asked for any suggestions for improvement to be sent to him and he would see if they could be incorporated.

14. Future Community Events for promoting the Village

JH suggested that there could be a number of events held within the village to improve the vibrancy and spirit of the community. Examples given were Bonfire night celebrations or a big event every few years. This was discussed and JH will explore this further.

15. Great Horwood Feast

The Clerk requested two volunteers for when the fair comes to the Village to put notices on cars and to collect the rent. AM agreed to put the notices on cars and JH will collect the rent cheque.

16. Online Banking Forms

These were completed in the meeting and returned to the Clerk.

17. To agree items for payment

Cllrs Mayne and Gilbey agreed to authorise the payments.
