Great Horwood Parish Council Minutes of an Ordinary Parish Council Meeting held on 11th June 2012 at 7.30pm in the Village Hall, Great Horwood.

### Present: Cllr John Gilbey (Chairman), Cllr John Scholtens, Cllr Russell Margerrison, Cllr Angela Mayne, Cllr Valerie Porritt, Karen Francis (Clerk) 1 member of the public

- <u>To receive apologies for absence</u> Cllr Bennett-Coles gave apologies due to work commitments while Cllr Lamberton gave apologies due to holiday commitments.
- 2. <u>To confirm the Minutes of the Meeting held on 14<sup>th</sup> May 2012</u> These were approved without modification.
- 3. <u>To receive declarations of interest</u> No declarations of interest were received.
- 4. To consider matters arising from the Minutes of the last meeting
  - Speedwatch Clirs Mayne and Porritt attended the last NAG meeting where speedwatch was discussed. It was
    agreed amongst the councillors that the local police office needed to be contacted to obtain further information
    and that it would be beneficial to put a note in Focus looking for volunteers. Clir Porritt agreed to write the note.
  - Public Consultation This will be held in the village hall on Saturday 16<sup>th</sup> June to provide information about a proposed development at the back of 12 High Street.
  - Paving The Green Cllr Bennett-Coles is unable to find a contractor who can carry out this work. Cllr Mayne agreed to take this forward by asking another possible contractor.
  - RoSPA it is unknown whether the playground inspection has taken place.
  - Insurance this has now been changed to Zurich.
  - Bollards on The Green no update.
  - Sundial this was removed to make way for the marquees for the Diamond Jubilee party. It is currently being stored in the Village Hall.
  - Water Butts at the allotments no update.
  - Landowners in Singleborough Lane the Local Area Technician has asked for information on the landowners so that grips can be cut into the verges in order to reduce the flooding in Singleborough Lane.

### 5. Public Participation Period

Lawrence Renshell passed on his congratulations to the Diamond Jubilee committee for the excellent street party on Monday 4<sup>th</sup> July.

### 6. Planning Issues

- 6.1. Cllr Gilbey provided Councillors with an updated Planning Report which was ratified at the meeting. One new decision and three new applications had been received, and the planning report is attached to and forms part of these minutes.
- 6.2. The Clerk has obtained some informal accountancy advice which would indicate that any transfer of land between the Parish Council and the Recreation Charity would need to be done at market value as the parties are connected. She has contacted the legal team at BCC to see whether something else can be done and is awaiting a response.
- 6.3. No update has been provided.
- 7. <u>Report from the Recreation Committee</u> No update was provided.
- 8. Neighbourhood Planning Team Update

A report had been circulated prior to the meeting to Councillors. The consultation process has begun to advise all potential stakeholders of the intention to produce a neighbourhood plan. A draft vision and objectives have also been produced and is awaiting comments from the Neighbourhood Planning Team before it is circulated more widely for comment.

### 9. Footpaths Report

Robert Deuchar provided the following report:

All the Parish's footpaths were checked in mid May and a couple of wobbly stiles will be followed up.

10. Feedback on Diamond Jubilee celebrations

Cllr Gilbey gave a short resume of the celebrations. All went according to plan and the weather was kind. Money had been provided from the Lord of the Manor and some local businesses so thanks went to them. There is a small amount of money left which will go towards a pull-out colour spread in Focus next month. It was agreed the Clerk would write to the Diamond Jubilee Committee thanking them for their efforts.
