2. To confirm the Minutes of the Meeting held on 9th February 2015

A small amendment on item 11 was made changing TVP to AVDC.

3. To receive declarations of interest

Cllr Gilbey stated he had not commented on planning application 15/00775/ATC as it concerned a neighbour.

4. To consider matters arising from the Minutes of the last meeting

- Bus timetables have been installed.
- The small trees in the planter in Pilch Lane have been removed.
- The defibrillator is now installed on the front of the Village Hall. Thanks were given to Cllr Mayne for leading the
 project and to David Mayne for the installation of the cabinet in very wet weather.

Public Participation Period

Gill Wood thanked the members of the Neighbourhood Plan for their work and efforts. Cllr John Chilver also thanked the Neighbourhood Plan team. He also informed the PC of the Buckingham Local Heathcare Review meeting on Wednesday at Buckingham Community Centre and a new online consultation for changes to library opening hours.

7. Planning Issues

- 7.1. Councillors were provided with an updated Planning Report which was ratified at the meeting. Three new applications had been received and three applications had been determined. The planning report is attached to and forms part of these minutes.
- 7.2. Some problems highlighted to AVDC have now been resolved but there is still one problem outstanding which relates to comments made to coordinators. AVDC have been notified of the problem but still have not responded. .
- 7.3. An application has been made to build 1855 homes to the east of Whaddon Road, Newton Longville (15/00314/AOP). The traffic analysis has been received from AVDC but it is not wide enough to consider Great Horwood. Cllr Gilbey has asked the Clerk to contact AVDC to request the traffic analysis is widened.

8. Report from the Recreation Committee

The Rec equipment is generally is good condition although there are some minor repairs which need to be made. A Work Party is planned for 29th March and any help from users of the Rec would be greatly appreciated.

Bucks University Technical College is still being pursued but it is likely that alternative arrangements will be needed to get the basketball area paved.

It has also been agreed to organise the seventh 'Picnic on the Pece' which will be held on Sunday 7th June.

9. Footpaths Report

All the Parish's footpaths and its bridleway have been inspected and pruned between 22 February and 4 March. There is a new metal pedestrian gate (replacing a stile) on FP5 where it leaves Singleborough Lane just north of the bridge over the stream.

10. Neighbourhood Plan

The referendum for the Neighbourhood Plan was held on Thursday 5th March. There was a steady stream of residents voting throughout the 15 hours that the polling station was open with the last person casting their vote at 9.55pm.

The Parish Council were allowed to nominate up to 10 scrutineers to witness the count which started soon after the polling station closed at 10.00pm Those who attended were Cllrs. Gilbey and Scholtens, David and Mary Saunders, Gill and Mick Wood, Monica Gilbey, Jo Waggott and Heather Blake and they were all very impressed by the extremely careful and thorough way in which the count was conducted and Cllr. Gilbey expressed the thanks of the community to the Returning Officer and the Poll staff.

Results have been posted on the PC noticeboard and the details were as follows:

Of the 815 residents eligible to vote 491 actually voted and of these 87 were postal votes. 447 (91%) votes were in favour of approving the Neighbourhood Plan while 44 (9%) were against.

The turnout was 60.2% which is the highest turnout of any Neighbourhood Plan referendum in England to date.

The Plan will now be made by AVDC and any outstanding and subsequent planning applications should now be decided using the information in the Neighbourhood Plan.

11. Devolved Services

Cllr Gilbey had asked County Cllr John Chilver to attend the meeting to inform the PC on the current state of devolved services across the county. Cllr Chilver explained that the current proposals are optional and the first stage starts in April 2015. Most PC's have been asked to take on grass cutting but there are many services that are available to be devolved or will be soon.

The current situation is that each Parish which has accepted the offer is given a proportional amount of the Council budget for devolved services and then encouraged to form clusters with other Parish and Town Councils. There is also a small amount of funding available for Health and Safety Training and Public Liability Insurance.

There is currently guaranteed funding for the next four years from BCC and there is the option for PC's to take up the offer from April 2016. However there is no guarantee the offer from BCC will remain the same.

Cllr. Gilbey expressed his strongly held view that many of the services currently provided by Bucks CC and AVDC will be curtailed or ceased in future years as government funding to local councils is further reduced and future parish councils will have to decide whether to manage without the service or to fund them through the precept. Examples of areas where this has already taken place include Youth Clubs and Libraries.

12. Winslow Police Station

Since the last meeting the Clerk had written to the Chief Inspector of TVP and the Crime Commissioner. The Chief Inspector had responded only giving reasons to the closure and nothing else. There has been no response from the Crime Commissioner.

Winslow Town Council are looking at funding the police office so that it remains open. Cllr Gilbey asked the rest of the Parish Council if they would be willing to provide some funding too. After discussion it was agreed an amount of up to £1000 would be ring-fenced from current year reserves and that the Clerk would contact Winslow Town Council to inform them of this decision.

13. Annual Parish Meeting

The APM will be held on 13th April at 7.30pm. Village organisations have been invited to attend and make a short presentation if willing.
