Minutes of the Annual Parish Council Meeting held on 11th May 2015 at 7.30pm in the Village Hall, Great Horwood.

1. Introductions

Cllr Scholtens welcomed the new and returning Councillors, thanked the retiring councillors for all their hard work then each Councillor gave a short introduction

2. To receive apologies for absence

Cllr Gilbey (JWG) was unable to attend as he was on holiday. He sent his best wishes to the new Councillors.

3. To elect the Chairman of the Council for 2015-2016

A nomination had been received from Cllr Scholtens. This was seconded by Cllr Gilbey and all councillors were in favour so Cllr Scholtens was elected.

4. To receive the Chairman's declaration of acceptance of office

Cllr Scholtens confirmed his acceptance of the appointment.

5. To elect a Vice-Chairman of the Council

A nomination had been received from Cllr Gilbey. This was seconded by Cllr Scholtens and all councillors were in favour so Cllr Gilbey was elected.

Cllrs were also asked whether they would be prepared to help move the MVAS between sites. Cllrs Holland, Scholtens and Mayne will also provide assistance as well as Duncan Trigg who also offered his services. Cllr Mayne will co-ordinate.

- 8.2. Again the Chairman and Vice-Chairman are automatic members of the Recreation committee. It was agreed that Cllrs Holland and Gunn would join the Committee.
- 9. To agree payment of annual subscriptions to BMKALC, AVALC, Community Impact (Bucks), NBPCC & BPFA As the subscriptions to these organisations are budgeted for in this financial year, all Councillors voted in favour of paying them.

10. To confirm the Minutes of the Meeting held on 13th April 2015

These were approved without modification.

11. To receive declarations of interest

12. Councillor Contact Details

Councillors provided updated contact details which will be published in Focus and on the PC Noticeboard.

13. To consider matters arising from the Minutes of the last meeting

- The Clerk confirmed that she had contacted The Lawn Ranger to ask him to confirm when he was cutting the grass at Horwode Pece. Cllr Mayne stated the grass had not been cut in May and the Clerk will contact The Lawn Ranger to ask when this will take place.
- Nothing has been heard from Wendy Taylor regarding the abandoned car on The Green. The Clerk will now contact AVDC Abandoned Cars dept.
- The Clerk advised Eon were no cheaper under a fixed contract for electricity.

 Liz Nicholls thanked the Parish Councillors who served on the previous Parish Council and wished good luck to all the new Councillors.

15. Planning Issues

15.1. Councillors were provided with an updated Planning Report. One new decision has been made and four new applications have been received. This information can be seen in the planning report which is attached to and forms part of these minutes.

16. Report from the Recreation Committee

- A picnic table has been installed, grass has been mowed, hedges cut and edges strimmed.
- The promise of BBQ structures from Buckingham UTC construction department continues.
- The management committee are pursuing the addition of Monkey Bars to the Pollux.
- Picnic on the Pece is 7th June from 12noon.
- Angela Mayne and Valerie Porritt were thanked for their time and commitment to the Trust while representing PC interests over the previous four years.

17. Footpaths Report

There is nothing to report this month but Robert Deuchar has confirmed he will continue as Footpath Monitor for the next year.

18. Summer Planters

Cllrs agreed that the five planters should be replanted for the summer at a total cost of £180. The areas around two of the planters, one in Pilch Lane and one in Little Horwood Road, will also need some strimming and the hedges nearby trimmed slightly. The Clerk will contact Robert Heady.

19. Soakaway on The Green

The contractors who have been appointed to carry out these works are proving unreliable and so an alternative contractor has been contacted. Concern was raised over the legalities of digging up The Green. The Clerk will forward the information she has regarding this to MS and JRH for consideration.
