# Victorian Galleywood

The following piece appeared in the Essex Chronicle on 6 May 1910 and appears to be an unsolicited contribution from a satisfied reader. We're accustomed to slogans that almost shout at us these days, but what could be more convincing than the final sentence in this letter.

### MAKE YOUR OWN HAIR TONIC

A home made hair tonic that was highly recommended for its remarkable hair growing properties, as well as for stopping falling hair, revitalising the hair roots and destroying the dandruff germ was of special interest to me as the formula was one which I myself have seen used in countless cases with the most astounding benefit, thus confirming my belief that home made hair preparations are the best. For the benefit of those who have not seen it before I give the formula herewith.

The Common was being dug up and taken away.

To the Chelmsford Rural District Council from Great Baddow Parish Council 7 March 1898

### Dear Sir

I am instructed by my Council to forward to you the enclosed copy resolution passed at their meeting on the first inst. In so doing I am requested to inform you that Mrs Rayner has opened a large hole at the back of the grandstand from which large quantites of sand and gravel have been extracted and carted away to Rettendon. This is quite distinct from anything connected with the manufacture of bricks on the Common.

I am also to inform you that a large excavation has recently been made to the NW side of the footpath, the subject of recent proceedings, and that planks have been laid across it and on trestles above it and the footpath obstructed by the wheeling of barrows over it.



### Common bought for £2000

It's such a significant feature of our village that we feel that, notwithstanding the legal language, members will be interested to read how it was bought by the Council from its private owner.

# This Converance is made the twenty third day of

December one thousand nine hundred and forty two-BETWEEN HENRY LINDSAY ARCHER HOUBLON of Welford Park Newbury in the County of Berkshire a Major (retired) in His Majesty's Army (hereinafter called the Vendor) of the one part and THE RURAL DISTRICT COUNCIL CF CHELMSFORD in the County of Essex (hereinafter called the Council) of the other part WHEREAS the Vendor is the estate owner in respect of the fee simple of the property hereby conveyed subject to the rights (if any) of the Commoners of the Manor of Great Baddow in the County of Essex and to the rights (if any) of the public and to the Licences and Agreements set forth in the First Schedule hereto but otherwise free from incumbrunces AND WHEREAS the Vendor has agreed with the Council for the sale to the Council for the sum of Two thousand pounds of the fee simple of the said property hereby conveyed subject to the rights licences and agreements aforesaid but otherwise free from incumbrances and the Council has agreed to enter into the covenant hereinafter contained NOW THIS DEED WITNESSETH as follows'-

1. The Vendor as BENEFICIAL OWNER hereby conveys unto the Council ALL and SINGULAR the parts of Galleywood Common in the County of Essex as now remain waste or common land of the Manor of Great Baddow Together with all and singular the rights and privileges in respect of the said common and premises now vested in the Vendor as Lord of the said Manor TO HOLD the same Unto the Council in fee simple subject only to (a) the aforesaid rights (if any) of the said Commoners (b) the aforesaid rights (if any) of the public and (c) to the Licences and Agreements set forth in the First Schedule hereto

2. IT is hereby declared that for purposes of identification only and not of limitation the parts of Galleywood Common in the County of Essex which now remain waste or common land of the said Manor are edged pink on the plan annexed hereto

3. THE Council hereby covenants with the Vendor that the Council and its successors in title will maintain Galleywood Common hereafter in perpetuity for the benefit of the inhabitants of the surrounding locality but nothing in this clause contained shall prevent the Council from regulating the said Common in accordance with statute 4. THE Vendor hereby acknowledges the right of the Council to production of the

documents set forth in the Second Schedule hereto and to delivery of copies thereof and hereby undertakes for the safe custody thereof

IN WITNESS whereof the Vendor has hereunto set his hand and seal and the Council has caused its common seal to be hereunto affixed the day and year first before written
