- 1. It was resolved that the Clerk's salary be calculated by reference to Salary Scale LC2 point 17 (currently LC2 point 16). Based on NALC 2020, this would be subject to any backdating required when NALC issue the new pay scales effective 1 April 2021.
- 2. Clerks expenses. It was agreed that the Clerk would make a monthly expense claim for expenditure incurred in carrying out her duties. The current round sum expense allowance would not be paid. Councillors would monitor the expense claims.
- 3. Pension. The Clerk had advised the Council that she had investigated the current pension arrangements and she believed it would not be beneficial for her to continue in the Workplace Pension Scheme. Hence, she proposed to opt out of the scheme. Councillors agreed an addition of 10p per hour if the Clerk did not wish to be included within the Workplace Pension Scheme.
