23/162 Welcome and Apologies for Absence. The Chairman welcomed everyone, no apologies for absence.

23/169 Matters Arising from previous minutes.

Item 1. Previous Minute No. 22/029 woodland known as The Lodge Plantation, Gosfield parcel of land for inclusion into the Nature Reserve, ongoing with Solicitors and Land Registry.

Item 2. Previous minute No. 22/162 The Street/Hedingham Road Hedges overhanging pavement – some works has been carried out, Essex County Council Highways contacting residents.

Item 3. Previous minute No. 22/208 village pump – works now completed by Eastlight. Parish Council to consider the purchase of a plaque for it so to remove item to be on the next agenda.

Item 4. Previous minute No. 22/221 old village sign – Will be installed shortly it was discussed that it would be better situated in the new community shop garden, item to be on next agenda.

Item 5. Previous minute No. 23/126 Essex County Council Highways – Proposal for Improved Road Safety in Gosfield – update by Cllr Willis that he had carried out a risk assessment along Braintree Road but given that he now has further information that was discussed in item 23/164 above this will continue to be work in progress and ready for the next meeting.

Item 6. Previous minute No. 23/148 Horse Chestnut Tree – Permission would be required from Essex County Council and a letter of support from Cllr Siddall, awaiting feedback from a member of the public ongoing to confirm if still required.

Item 7. Previous minute No. 23/139 Trees along Church Road – reported to Essex County Council Highways Ref: 2859401 the area in question has been inspected a dead tree was noted and two oaks which appear to be in decline, with major deadwood noted throughout the crowns of both trees. Highway records have confirmed that the trees in question would be classed as boundary features, which means the adjacent land owner would be responsible for their maintenance. However, on this occasion ECC will be undertaking the remedial works required, on a without prejudice basis.

ECC will be carrying out a decay detection survey of both oak trees. Once the decay detection survey has been completed, officers will have a better understanding on the extent of decay present within the basal areas of both trees and whether they are safe to retain. The survey is due to take place on 22 August. Remedial works can then be considered.

Item 8. Street Lights at the Lindens – The Parish Council never approved these lights, BDC Planning confirmed that Essex County Council Highways have permitted development rights under section 278 of the Highways act to install street lights.

23/170 Neighbourhood Plan.

Item 1. Neighbourhood Plan Committee meeting had taken place on 1st August the draft grant application for Groundwork UK and the summary of recommendations from engagement with public & experts for consideration was discussed.

The Maurice Rowson village hall revenue is up and they will be improving the sound system.

Raised rota. Dismantle top section to expose bearing and pack with grease. £285.00 Please note, if the bearing is found to be worn, a new bearing will be quoted for.

Spring Horse. To descale and repaint spring and lower frame. £235.00

Spring Dog. To descale and repaint spring and lower frame. £235.00

Aerial runway. To dismantle runway to inspect cable and chain suspension, to reassemble and retention cable £385.00

Bonded mulch. Supply and install 2m2 of bonded mulch around each spring mobile to prevent soil erosion, 4 in total. £828.00
