24/260 Welcome and Apologies for Absence. The Chairman welcomed everyone, apologies for absence received and accepted from Cllr Willis (due to holiday) Cllr Pawsey (due to illness) and District Cllr P. Schwier (due to work commitments).

24/261 Statement by the Chairman. Chairman read out the following statement.

"I would like to make a short statement in relation to recent Facebook posts.

These posts have been very damaging to the Parish Council as a whole and I would like to remind councillors of our Code of Conduct which we approved at the last Parish Council meeting.

- 19.1 our conduct as an individual councillor affects the reputation of all councillors
- 19.8 Parish Councillors treat other councillors and members of the public with respect
- 19.8 Parish Councillors do not bring their role or local authority into disrepute

I do not wish to go into any detail with regards to the posts.

I would however urge and encourage you all to ensure that you follow our code of conduct that we have approved and signed up to."

24/262 Declaration of Interests.

To receive any disclosable pecuniary interests or non-pecuniary interests, or interests relating to items on the agenda. Members of the council are subject to the Local Authorities Code of Conduct.

Cllr Strudwick queried that the wording on the agenda for this item should be amended now that we have adopted the new code of conduct, Clerk to investigate the correct wording and for it to be on the January agenda.

Cllr R. Edwards non-pecuniary interest relating to item 24/266 was received and accepted.

24/263 Public Participation Session with respect to items on the agenda and other matters that are of mutual interest.

A member of the public informed the Parish Council that he is still awing a decision notice from BDC to carry out tree works in the nature reserve. Gosfield Wood is partly on the market and a section being sold. It is protected through the national planning policy framework, he has sent a letter to BDC detailing his concerns and article 4 direction is a general development order which specifies items not required for planning permission, permitted development rights and he would like the Parish Council to support his letter.

A member of the public expressed his concerns relating for the late addition to the call for sites application, two previous planning applications have been refused in the past by BDC, the area is outside the village envelope, poor access/entrance onto the site and some of it is on a floodplain.

24/264 County and District Councillors to address the members if present.

County Councillor Chris Siddall - updated that the speed limit relating to Gosfield Road as discussed with Tom Cunningham was going through the process and is in the system. Essex County Council Highways looking at the speed limits in the area. Zebra Crossing in "The Street" also in the system to be investigated further to see if it would meet the criteria for the area proposed. Speed surveys will be required for both.

Manhole covers item 24/268 Item 6 has been chased up, work due to be completed in December also item number 24/268 item 7 it was confirmed that the white lines have been painted on Church Road near the Kings Head pub but not on The Street down to The Limes Cllr Siddall to follow up.

Budget setting is in progress possibly over a 5-year period. The devolution white paper on how Councils will look in the future has been published and across Essex will possibly become a combined authority. Upgrades on the Highways report it website has been implemented.

It was noted that the invoices from Eon for electricity are incorrect because for the last few months we have only received one for daytime electric and still awaiting one of evenings and weekends.

Anglian water has sent an estimated invoice which is high, meter reading required.

24/268 Matters Arising from previous minutes.

Item 1. Previous Minute No. 22/029 woodland known as The Lodge Plantation, Gosfield parcel of land for inclusion into the Nature Reserve, update by Cllr R. Edwards.

Cllr R. Edwards explained that in 2022 Gosfield Parish Council had paid £1250 plus VAT for the quoted legal fees in respect of the registration of the land, deed of gift from the Letch family and registration in Gosfield Parish Council's name. He had now received an email from Holmes and Hills in which they have revised the fee estimate from £1250 plus VAT to £3500 plus VAT, hence they required a payment of £2700 including VAT. It was agreed that Gosfield Parish Council did not wish to have anyone acting on their behalf and that Cllr R Edwards should contact Holmes & Hills to register a complaint. If this complaint was not satisfied, then it was agreed to refer it to the Solicitors Regulation Authority. Cllr R Edwards will also check directly with Land Registry in order to ascertain the current position.

Proposed by Cllr R. Edwards, seconded by Cllr Strudwick, all in favour resolution passed.

Item 2. Previous minute No. 24/107 Complaint letter to Clarion and BDC regarding affordable housing – the latest information is that they did follow the correct procedure, it was on the market and a Gosfield resident was going through the process but because they pulled out of the sale it is now on the open market again.

Item 3. Previous minute No. 24/138 VE Day 8th May 2025 – there will be a display of vehicles in the village hall car park and an event has been arranged, the Golf Club have kindly donated £250.00 towards this event.

Item 4. Previous minute No. 24/129 Open Space land at the top of Meadway – access gate to knee high fencing (BDC) public rights of way concerns regarding footpath 11, replacement of trees and to discuss the transfer of land, no new update ongoing.

Item 5. Previous minute No. 24/146 The Beacon - Ongoing.

Item 6. Highways - Two noisy manhole surface/covers have been reported to Essex County Council Highways ref: 2947272 and ref: 2924085 The Street and junction with Hall Drive – update by Cllr Siddall see item 24/264.

Item 7. Highways – White Lines. White lines on the edge of the road near the kerb from the Kings head pub down to the Limes. Reported to Highways ref numbers 373559, 3731561 and 2946334 – update by Cllr Siddall see item 24/264.

Item 8. Neighbourhood Plan - The next Neighbourhood Plan Committee meeting is scheduled to be held on 14th January 2025.

Item 9. Car Park – Awaiting news from the national lottery regarding funding and awaiting news from BDC relating to the S106 drainage funding.

Item 10. Public Footpaths 15 and 22 – Update is that this is still ongoing nothing has been agreed, however it was noted that it is very muddy and that the area has been ploughed.

How many lights are still SOX and how many would need to be changed over to LED to establish how much saving would be made. Item deferred as further information required

24/271 Community Speed watch.

New co-ordinator and volunteers required for Community Speed Watch, this has been advertised in the Grapevine. To advertise again in the new year as volunteers will need to come forward for the speed watch group to continue to operate in the village. In the meantime, all equipment, road sign, two speed cameras and hi vis jackets to be returned to the Parish Council to place into storage.
