**25/239 Welcome and Apologies for Absence**. The Chairman welcomed everyone, apologies for absence received and accepted from Cllr Pawsey (Due to illness).

#### 25/242 County and District Councillors to address the members if present.

County Cllr Siddall gave an update on the Local Government Reform item 25/250 and explained the Mayoral elections have been postponed. Essex County Council are in favour of 3 new unitary authorities, public consultation is now open until 11 January 2026. Essex County Council are cutting setting their budgets. Surface water flooding is an issue at Sloe Hill and is being investigated. As there is money left in the LHP budget he will put forward for white lines to be painted on the road from the Kings Head pub down The Street. He confirmed that he would give a Community Grant of £2,000.00 towards the work (see item 25/255) in the Nature Reserve. Thanks expressed to Cllr Siddall.

Cllr Schwier was not present but continues to send regular update, he has given £800.00 Community grant towards work in the Nature Reserve. Thanks expressed to Cllr Schwier.

# Item 1. Planning updates.

An appeal has been made to the Secretary of State against an enforcement notice issued by Braintree District Council on 2 September 2024. Petersfield Farm Petersfield Lane Gosfield Essex CO9 1PU

Alleged Breach: Appeal against the unauthorised material change of use of the land for the siting of containers for storage purposes and the construction of an earth bund along the Eastern boundary. Awaiting notification of a decision.

# Enforcement Case 20/00117/UBW3: Planning ref: 20/00915/FUL Oaklands Shardlowes Farm.

Update by BDC 17 August 2025. The planning history at this location shows that an enforcement investigation was raised in March 2020 under reference 20/00117/UBW3 in order to investigate a building which had been constructed without the benefit of planning consent. A planning application was subsequently received and refused and an appeal to the planning inspectorate followed, this was dismissed favouring the Council's position. The enforcement history indicates that formal enforcement action was not supported by the Planning Development Manager in this instance, therefore the building has become time barred from enforcement action under section 171b Town & Country Planning Act 1990 rendering it lawful, the enforcement investigation was closed accordingly.

Cllr Schwier followed this up again, and the Parish Council have received a reply, an apology from Braintree District Council and they will look at ways of improving their internal procedures. To remove item from future agendas.

#### 25/254 Potential Open Space Improvements (POSI) Update.

To consider various projects to add to the Braintree District Council Potential Open Space Improvements (POSI).

It was agreed to leave the existing as follows:

Car park resurfacing, to replace boundary around the playing field.

The Spinney – purchase land and remediate suitably to allow public access and enjoyment.

Gosfield Nature Reserve - Access track improvements.

New drainage system to the playing field and a new adult gym equipment/fitness area next to the pavilion.

To remove item, the replacement skateboard ramp

To add cycle path to Halstead, improvements to Gosfield Nature Reserve, new play equipment and benches.

Proposed by Cllr T. Edwards seconded by Cllr Hough, all in favour resolution passed.

# 25/255 Gosfield Nature Reserve.

To discuss and confirm projects and grant applications as follows

- 1. Coppice the willow around Horseshoe Pond. This will increase light levels into the pond and reduce the accumulation of leaf litter, increasing marginal habitat and improving conditions for pond life. TPO Consent is expected by 24th December but may be later due to Christmas.
- 2. Erect rustic-style fence using natural materials along the path on the west side of the Horseshoe Pond. The path is the main link from Greenfields to the village centre and can be slippery when wet. A fence will improve the user experience.
- **3.** Coppice/ lay hedge adjacent to path from Greenfields r/o Edmund Green. This will reduce overhang of the path, improve light levels and reduce leaf drop in neighbouring gardens, and improve nesting habitat for birds, by providing denser young growth. TPO consent obtained.
- **4.** Organise a volunteer day to clear bramble round the acid grassland. Currently planned for Saturday morning 31st January. Bramble growth will encroach on the important acid grassland habitat unless checked. This work is suitable for volunteers and will improve the idea of "ownership" of the Reserve by the local community.
- **5.** Erect a chicken wire fence around the fern area by the brook to exclude deer to prevent browsing damage to the ferns. The stand of Male and Broad buckler Ferns has been heavily browsed by Muntjac, dramatically changing the character of the area and reducing visual and habitat value.
- **6.** Replace two footbridge decks. There are 4 footbridges in the Reserve, essential to the network of paths; two have been upgraded.
- **7.** Clear selected fishing swims to improve access for fishing. Since the H&DAC surrendered the fishing licence, the swims have become overgrown. Improvement of the swims will enable members of the local community to fish more easily.

All of the above works to be completed by 31st March 2026 in order to receive the following grants towards the cost of the works.

Grant of £800.00 from District Cllr Schwier and a grant of £2,000.00 from County Cllr Siddall.

Proposed by Cllr T. Edwards seconded by Cllr Hough, all in favour resolution passed.
