**22/018 Welcome and Apologies for Absence**. The Chairman welcomed everyone, apologies for absence received and accepted from Cllr Beavis and Cllr Bloomfield (due to work commitments).

22/020 Public Participation Session with respect to items on the agenda and other matters that are of mutual interest.

A spokesman for the Wethersfield Air Base Scrutiny Committee outlined the issues with the planning proposal for a new prison on Wethersfield Air base, one of seven new prisons to be built in the UK. This would include 4,000 people, staff and inmates, 3,000 vehicle movements a day and will take 10 years to complete the build. This is a substantial development for the area and the site is too remote. However, this would bring employment to the local area. GNR after Friday's storm there has been no significant damage, coppicing work to be undertaken shortly. The oak tree near 6 DeVere Place has been completely stripped all around. The application for works to trees near 5 DeVere Place will be reapplied for. Thanks expressed to Stephen Westover.

A member of the public aired his concerns regarding the Parish Council lack of funds and possibly getting into long term debt regarding the building the extension onto the pavilion. The Queens Platinum Jubilee was discussed and the social club will be organising an event.
