A member of the public raised concerns about the Limes development there are no landscape plans laying out the open space areas, no provision for access from the Limes and no provision to stop vehicles parking on the open space areas. After checking with land registry, the developers do not own the land it is registered to Eastlight, the public should have right of way over it please can the Parish Council contact Eastlight to reinstall a gateway, it was agreed to do so.

Cllr Siddall reported that ECC have set their budget and there will be a 3.5% increase. 1.5% on council tax and 2% towards adult social care there will no longer be a Highway Ranger team that carried out low maintenance issues such as sign cleaning and verge clearing. Hedges (see item 23/029 Item 5) was discussed as a member of the public would like to know why he had to cut his hedge but others have not, a list was passed to Cllr Siddall of those that have not cut back their hedges at the last meeting, all of which have a separate reference number, clerk to resend e-mail list along with the list of potholes for Cllr Siddall to follow up and update at the next meeting. The Bournebrook Hill highway repair work will be carried out later this month, potholes in the village have been reported and these were discussed. He will chase up the locality grant funding which we may be able to put towards car park resurfacing.

Cllr Schwier not present, but thanks expressed for the Councillors Community Grant of £1,850.00 funding received towards resurfacing of the pavilion car park.
