Item 2. To consider whether to re-invest the fixed rate bond in Cambridge and Counties Bank in respect of the pavilion sinking fund which matured on 13 January 2022.

It was discussed and agreed to write to Sport England to advise them of our intentions to possibly use the money towards the community shop extension and to increase the sinking fund in future.

22/008 Precept/Budget for 2022/2023.

As required by section 33 of the Localism Act 2011, Parish Councillors are obliged to leave discussions where they have a disclosable pecuniary Interest. To participate in the setting of a precept for the Council, the councillors will require a dispensation, and for this purpose, Gosfield Parish Council resolves to delegate to the Clerk the power to grant a dispensation from exclusion to all Councillors for the purpose of considering and setting the precept. Proposed by Cllr Bloomfield, seconded by Cllr Beavis, all in favour, resolution passed.

22/009 Budget/Precept 2022/2023.

Item 1. After discussion about the budget, it was agreed to include £500.00 for clearing of the swims at the GNR not for water testing (to change headings in the accounts) and to include £75.00 for a Christmas tree, therefore the budget was set at £ £36,931.00.

Item 2. The precept for 2022/2023 was set at £36,931.00 (an increase by 2.96%).

Item 2. To discuss and update on the community benefit society, notice of explanation regarding the share scheme to be published in the Grapevine which must also include the car park to the building project.

Item 3. Fund Raising for the pavilion extension – Cllr Colyer and Cllr Waters have held a meeting to discuss and consider various funding options including the share scheme.

Item 4. Local Plan – Cllr Beavis gave an update that they are confident that this will move forward for adoption however they are struggling to get a 5 years housing supply.

Item 5. Neighbourhood Plan – A lot of feedback regarding the resident's survey to collate the information.

Previous Minute No. 21/027 Hedging To consider hedging the playing field, from the play area to Hall Drive, some hedging has been plant by Cllr Waters but not enough to complete the project, this item to be removed from the agenda for now. Proposed by Cllr Bloomfield, seconded by Cllr Colyer, all in favour resolution passed.

Item 7. Previous Minute No. 21/118 Playing Field Management Committee- have looked at the constitution and one clause need to be confirmed and should be available at the February Parish Council meeting.

Item 8. Previous Minute No. 21/186 Purchase of copper beech tree to be planted at the top of the Playing Field – Cllr Waters suggested a plaque to commemorated the Queens Platinum Jubilee should be purchased with this item. Proposed by Cllr Edwards, seconded by Cllr Beavis, all in favour, resolution passed.

Item 9. Previous Minute No.21/192 Footpath Map – ongoing.

Item 10. Previous Minute No. 21/161 Lighting the Beacon - Cllr Cowie to ask the guides if they are interested in participating.

Item 11. Previous Minute No. 21/197 Speed Camera update by Cllr Moutard, this item still ongoing and awaiting further information regarding extra funding. The Speed watch coordinator is stepping down so looking for a new volunteer to take on the role.

Item 12. (Previous minute no. 21/133) Highways Priority list of highway improvements for Gosfield issued by Cllr Beavis, to be on the February agenda.

Item 13. Previous Minute No. 21/111 Gosfield Nature Reserve Risk Assessment. Cllr Bloomfield to draft a risk assessment to be sent to Westover Woodlands for comment and to all Councillors prior to this meeting – ongoing.

Item 14. Improving the water quality at the GNR – Cllr Moutard gave an update that this was no longer required, item to be removed from the agenda.

Proposed by Cllr Edwards, seconded by Cllr Pawsey, Cllr Hough in favour, resolution passed.

Cllr Bloomfield, Cllr Moutard, Cllr Cowie wish the original vote to remain.

Cllr Beavis and Cllr Colyer abstained.

22/015 Pub parking.

The Kings Head have asked whether they can use the playing field car park as an overflow for the pub.

Cllr Edwards explained the insurance implications regarding the carpark – it was agreed that anyone could use the carpark at any time however, it is in a bad state and it was agreed to temporarily fill in the holes, Cllr Moutard to approach the developer at Meadway for some hardcore.

Proposed by Cllr Edwards, seconded by Cllr Pawsey, all in favour resolution passed

22/016 To receive reports from outside bodies, training courses, village representatives, and Parish Council working groups.

Cllr Moutard reported that she had attended a meeting regarding the Wethersfield Air Base scrutiny committee but as the representative of Gosfield Parish Council does not know our views on the subject so this item to be on the next agenda.
