23/001 Welcome and Apologies for Absence. The Chairman welcomed everyone.

Apologies for absence received and accepted from Cllr Bloomfield (due to family commitments) and Cllr Pawsey (illness).

23/002 Declaration of Interests.

To receive any disclosable pecuniary interests or non-pecuniary interests, or interests relating to items on the agenda. Members of the council are subject to the Local Authorities Code of Conduct. A non-pecuniary interest (Para 8.1 of Gosfield Parish Council's code of conduct) was received and accepted from Cllr Edwards Cllr Colyer and Cllr Waters relating to agenda item 23/012 item 4 the community shop, also, from Cllr Edwards relating to agenda item 23/007 Item 2. 23/003 Hastoe Management Company.

Eddie Bacon the Development Manager from Hastoe Group attended and discussed the Lindens development and affordable housing. There with be 4 rented and 2 shared ownership. Hastoe Management Company will work in conjunction with BDC who currently have a list to see if people are eligible for an affordable house, there are 10 people looking for affordable houses in Gosfield at present, public to contact BDC direct. There will be a management company in place who will be responsible for the open space area, grass cutting etc.

23/004 Public Participation Session with respect to items on the agenda and other matters that are of mutual interest.

A member of the spoke confirmed that planning permission had been granted for solar panels on the village hall, thanks expressed to the Parish Council for their support.

23/005 County and District Councillors to address the members if present.

Cllr Siddall reported that the speed survey had bee carried out near the lake (see item 23/012 item 6) and that it had shown vehicles were within the limit so does not conform. Bournebrook hill highway repair work will be carried out later this month, potholes in the village have been reported and these were discussed. Cllr Siddall has put in a proposal to the LHP to change the speed limit along Braintree Road to High Garrett to 40mph he will also put in a proposal to the LHP to change the speed limit near the school to 20mph. Still no update regarding the bus stop in Halstead Road. ECC have set their budget and there will no longer be a Highway Ranger team that carried out low maintenance issues such as sign cleaning and verge clearing. Hedges (see item 23/012) was discussed and a list passed to Cllr Siddall of those that have not cut back their hedges, all of which have a separate reference number, clerk to also e-mail list along with the list of potholes for Cllr Siddall to follow up and update at the next meeting. He has received our application for the community grant funding which we may be able to put towards car park resurfacing, however, not sure how much is available yet.
