25/001 Welcome and Apologies for Absence. The Chairman welcomed everyone, no apologies for absence received.

#### 25/002 Declaration of Interests.

Cllr Strudwick non-pecuniary interest relating to item 25/006 Planning application 24/02260/HH was received and accepted.

### 25/003 Public Participation Session with respect to items on the agenda and other matters that are of mutual interest.

A member of the public informed the Parish Council that he is still awaiting a decision notice from BDC to carry out tree works in the nature reserve.

A member of the public raised concerns relating to the new road surface from the Kings Head down and round the bend of The Street/Braintree Road which is coming up due to the water running constantly down the road due to blocked gully/drains which has been reported on several occasions – Cllr Siddall to chase up.

Cllr Strudwick spoke regarding 25/006 Planning application 24/02260/HH and explained the current situation relating to houses front gardens in that area.

#### 25/004 County and District Councillors to address the members if present.

County Councillor Chris Siddall — updated that the speed limit relating to Gosfield Road as discussed with Tom Cunningham was going through the process and is in the system. Speed surveys to be carried out to collect the data. Essex County Council Highways looking at the speed limits in the area. Zebra Crossing in "The Street" also in the system to be investigated further to see if it would meet the criteria for the area proposed speed survey now in progress for this area.

The devolution white paper on how Councils will look in the future has been published and Essex will possibly become a combined authority, Essex County Council voted in favour of the restructure.

District Councillor Peter Schwier - Not present but continues to send regular updates.

The Chairman updated regarding the enforcement at Low Ley plantation near the lake and the owner confirmed that they are trying to preserve the roots of the trees near the lake, no further action required.

To participate in the setting of a budget and precept for the Council, the councillors will require a dispensation, and for this purpose, Gosfield Parish Council resolves to delegate to the Clerk the power to grant a dispensation from exclusion to all Councillors for the purpose of considering and setting the budget and precept.

#### 25/008 Budget/Precept for 2025/2026.

**Item 1.** The Budget for 2025/2026 was discussed in great detail, it was agreed to pledge £20,000.00 of reserves for the car park project in order for Cllr Willis to go out to match fund and source further grant funding, the budget was therefore set at £50,090.00

Item 2. The Precept for 2025/2026 was set at £50,090.00 the Parish element of the band D tax rate for 2025/26 was set at £76.03 compared to £69.78 last year which was an increase of 8.96%. The reserves would be replaced over 4 years with £5,000.00 per annum included in the budget.

The Parish Council expressed thanks to the Responsible Financial Officer for all the work carried out on the above.

- Item 11. Public Footpaths 15 and 22 No update from Essex County Council Public Rights of Way.

Speed watch Previous minute no. 24/271 Update A new volunteer has come forward to become the coordinator he has completed Speedwatch Training with Essex Road Safety, and the instructor said that Speedwatch groups do not need to have calibrated speed guns anymore as a larger margin of error in speed readings is established due to issue of guns not being calibrated, so no further action required. Clerk to contact to see how many and when shifts will recommence.

Gosfield Wood is partly on the market and a section being sold, it is protected through the national planning policy framework, the Parish Council has sent a request to BDC. The Chairman updated regarding the enforcement at Low Ley plantation near the lake and the owner confirmed that they are trying to preserve the roots of the trees near the lake, no further action required. for an article 4 direction which is a general development order which specifies items not required for planning permission, permitted development rights to be put in place, still awaiting a reply from BDC.
