**21/140** To consider quote/fees from architects to draw up specification ready to submit application for building regulations. It was discussed and agreed that in order to move forward Stage 1, Submit information for discharge £516.00 plus VAT, Stage 2, Building Regulations and Structural Calculations £3,624.17 Plus VAT and Stage 3 Tender information £4,425.00 Plus VAT will be required. #### 21/143 Public Right of Way Footpath.

Public Footpath at the top of Meadway to discuss and consider for it to be re-routed on the definitive map. This item was discussed in great detail and the Parish Council agreed that they have no requirement for it to be it moved. If local residents want it moved then they will have to apply as individuals.
