26/097 Welcome and Apologies for Absence. The Chairman welcomed everyone and read an email received from County Cllr Chris Siddall, the Parish Council to respond and express their thanks.

26/098 Declaration of Interests.

26/099 Public Participation Session with respect to items on the agenda and other matters that are of mutual interest.

A member of the public (Chairman of Gosfield United Football Club) discussed item 26/108, the parcel lockers were explained and a survey to be carried out on 29th for further investigation as to where it would be sited etc. The signage was discussed and only one on the entrance to the ground would be required after car parks works are completed. The possible mobile bar was discussed the proceeds of which would go to help with the increased overheads of the club, premises and personal licences were discussed, further information required.

26/100 County and District Councillors to address the members if present.

District Cllr Schwier reported that the local plan responses are being reviewed by BDC. Wethersfield residents are about 800 and stable at the moment. Changes to waste bins commence on 1st June, the absorbent hygiene collection service will require residents to apply for it if required by phone or online direct full details, including eligibility criteria, accepted items and how to apply, are available on the Council website:

26/105 Matters Arising from previous minutes.

Item 1. Previous Minute No. 24/268 woodland known as The Lodge Plantation, Gosfield parcel of land for inclusion into the Nature Reserve, update by Cllr R. Edwards, item ongoing and Gosfield Parish Council have received reimbursement of £1500.00 from Holmes & Hills.

A possible septic tank in the area to be investigated – item to be on the next agenda.

Item 2. Previous minute No. 24/268 Complaint letter to Clarion and BDC regarding affordable housing – update re Edmund Green – ongoing.

Because there has been a local County Council election and Cllr Siddall is no longer the County Cllr the Highways related items below will now have to be passed onto the newly elected County Cllr to follow up.

Item 3. Highways – 30mph/40mph sign down, (propped up in the hedge) along Braintree Road Ref: 2977068 no update.

Item 4. Highways – Ref: 3829092 Overgrown vegetation, Hedingham Road – no update – ongoing.

Item 5. Highways Noisy manhole surface/cover has been reported on 6th January to Essex County Council Highways ref: 4011284 The Street. No update.

Item 6. Highways - previously reported pothole, gully (noisy) surface broken up ref: 4015244 & 4037962 Outside Tye Beams, in The Street opposite the Limes still causing problems no update.

Item 7. Highways – reported manhole covers protruding up from the pavement Outside Tye Beams, in The Street Ref: 4037957 no update.

Item 8. Highways - previously reported ref: 3602795 Blocked gully Halstead Road, no update.

Item 9. Highways – See previous minute number 26/073 item 8 reply received from Highways, and in the Grapevine. This item was discussed and it was agreed that Gosfield Parish Council would support any manner of trying to reduce speed of traffic through the village, however this item now be removed from future agendas. Item 10. Highway – road surface broken up near the war memorial reported 9/3/2026 ref: 4028882 – no update.

Item 11. Highways – White Lines. White lines on the edge of the road near the kerb from the Kings head pub down to Broom Cottage. Reported to Highways ref numbers 373559, 3731561 and 2946334 – confirmed works have been completed to remove from future agendas.

Item 12. Neighbourhood Plan – Awaiting update from Braintree District Council.

Item 13. Previous minute no. 143 Quality Council Bronze Award – ongoing work in progress.

Item 14. Meadway Development, Land West of Hedingham Road Community Land. Awaiting update relating to the transfer of the land as per the S106 agreement from BDC, as issues need to be resolved.
