22/176 Welcome and Apologies for Absence. The Chairman welcomed everyone, apologies for absence received and accepted from Cllr Cowie, Cllr Beavis, and Cllr Moutard (due to holiday and work commitments).

22/177 Declaration of Interests.

To receive any disclosable pecuniary interests or non-pecuniary interests, or interests relating to items on the agenda. Members of the council are subject to the Local Authorities Code of Conduct. A non-pecuniary interest (Para 8.1 of Gosfield Parish Council's code of conduct) was received and accepted from Cllr Colyer, Cllr Edwards, and Cllr Waters relating to agenda item 22/183 item 8 the community shop and from Cllr Pawsey relating to agenda item 22/02318/VAR and Ref: 22/02362/ADV.

22/178 Public Participation Session with respect to items on the agenda and other matters that are of mutual interest.

A member of the public spoke regarding the community shop and confirmed that £150,000.00 of Lottery funding grant had been approved and £10,000.00 also confirmed. Building work to start on 12th October 2022. The Chairman and Clerk signed a letter to the Holmes & Hills Solicitors instructing them to draw up a draft lease (see item 22/183 item 8) as soon as possible in order to release the lottery funding money. A member of the public spoke regarding the Maurice Rowson village hall that they are considering installing solar panels on the roof, a planning application will be submitted for the side roof, however, this has yet to be confirmed.

A member of the public spoke regarding tree works in the GNR and confirmed that consent has been obtained from BDC and a programme of tree survey specification of work, Westover Woodlands will be meeting contractors to obtain 3 quotes to be on the next agenda for consideration. He also spoke on item 22/181 Ref: 22/02318/VAR explaining that the application was for a change in design of the boundary fencing.

22/179 County and District Councillors to address the members if present.

Cllr Schwier reported as follows: - 360 Community newsletter is regularly issued. Love parks weeks BDC have a horticultural team of 30 Halstead Public Gardens have won an award. Improvements to Braintree town have been completed and now moving onto to Halstead Town and Witham. 12 Social houses have been handed over to Eastlight.

There may be some section 106 funding available to apply for to be put towards improvements to the playing field car park.

However, the grant received and the monies not spent by the end of March 2022 must be returned but due to technical issues this return has not yet been made. This invoice falls within the time of grants having to be paid back and re applied for (which we may not get). Therefore, there is not enough money allocated in the Neighbourhood Plan budget to cover the cost of this invoice.

It was agreed to pay the invoice and Cllr Bloomfield to send a full explanation letter with the return explaining that the money had been taken out of the awarded grant money even though the invoice date falls outside the catchment date.

Design and design codes, writing the plan (approx. 200 pages), specialised consultants may be required to put it all together. Engagement with the community – referendum.

Grants and funding for this project are only available to be applied for up to March 2023, so need to apply now if more money is required to continue with this project.
