The view was that is unlikely to achieve for the verge to be put in, but perhaps when new development at 'Hop Poles' starts they might consider doing that. It was proposed to try to ask for double yellow lines instead on the narrow section from pub entrance to 30mph sign.

Resolved: Cllrs Alan Pinnock and Mark Bloomfield to provide Clerk with exact location as to where double yellow lines should be. After receiving this information, the Clerk to write to County Cllr Susan Barker asking if that can be done at the time of the surfacing of the Bedlars Green.
