Ms Deriziotis explained how the time bank works. Time Bank is a register of people that have skills which they can offer to help other people. They earn time credits which can be used in various ways. The aim is to reach the isolated communities to get to each other and it's open to everybody. They would like to have enough members so that they don't need to travel far to help.
