20/422 Report by County Councillor.

Essex Welfare Service now evolved into Essex Wellbeing Service. Park & Ride at Chelmer Valley is now open. Potential for electric scooters to come in to use from the Park and Ride sites. Registrars are open again. ECC has made £1.1m available for Bursaries for Nursing and Social care. Majority of libraries are open. Consultation on the Chelmsford NE bypass is now open for comment. Arvis – App for book search for Library.

20/423 Report by Chelmsford City Councillor

Local Plan was adopted 27th May and individual Masterplans are now in the process of approval. Of interest to this parish is the Bloor Homes Masterplan in Broomfield/Little Waltham. This went through the public consultation process in Jan and Feb, with a revised plan available April, and is going through the approval process – Policy Board 16th July, then cabinet then full council for adoption – but ran out of time at the Policy Board and needs to be rescheduled. LW chair will be speaking.

City council are predicting a shortfall of £9m to £10m this year, mostly from loss of income due to Covid-19 – car parks, Leisure Centre, Theatres. Car parks are open but income is at 22% of normal levels. Leisure Centres open 27th July. Theatres are still closed until further notice. The current administration has decided to address the shortfall by using reserves and internal borrowing.

20/443 Ford End Average Speed Camera Project Update

LHP agreed to put up 50% of the £150,000 costs + £10,000 from GWPC with the rest from grants and local fund raising. Grant applications have resulted in 3 refusals (reason - felt that such schemes should be funded by Govt), Other grants on hold because of Covid-19 so because of these delays, LHP have kept the design activities in this year, but the main implementation has been moved to next year, as there will not be time to do the requisite planning processes in time. The supplier has reviewed its costs which has resulted in a reduction in cost to ££120,000 due to changes in technology and a reduction in the number of posts required. If LHP to supply 50% of the costs and the Parish Council £10,000, still need £50,000 from other sources.
