Minutes of the meeting of Great Waltham Parish Council held on Tuesday 12th December at Ford End Village Hall, Ford End at 7.30 pm.

23/1703 Chair's Welcome:

Chair: Gilbert.

<u>Cllrs:</u> Martin, Stephenson, Jackson, Micklem, Steel, Jenkins, McDevitt and Bradley.

23/1704 Apologies. Clirs Page and Palmer.

23/1705 Declarations of interests (existence and nature) with regard to items on the agenda

and any request for dispensation.

Cllr Steel – Item 23/1717 – Essex County Councillor.

Cllr Micklem - Item 23/1718 - Family Interest.

<u>23/1706</u> Public Participation session for any items regardless of its existence on the agenda 7 members of the public attended.

- Walthambury stores Road drain in front of the Beehive blocked. The Council agreed to report the matter online.
- Ford End Average Speed Camera (FEASC) 3 bad accidents in the last 12 months. 9 out of 10 cars trigger the warning signs for excessive speed. Lots of vehicles appear to be speeding when the SID (Speed Indicator Device) is in display.
- Speed Watch FE 2 vehicles pulled over in the hour today a PC was at the scene today and issued immediate tickets.
- Speed Watch FE Request to be notified in advance of the dates the SID unit is deployed.
 Also, the 20mph wig wags outside of the school have been broken for some time (see 23/177 below).
- FEASC Comments on the estimated revised costs published in the PC's November ECC update report (potentially up to £180k and additional survey costs in the region of £60k, a total of up to £240k). It was commented by a member of the public that the survey costs indicated seem high and they expressed the opinion that:
 - A <u>geotechnical survey</u> will be bore holes excavated so that the foundation for each new pole can be assessed, which since the local area is predominately clay and only two bore holes would be needed at a maximum of 3m deep, the cost would typically be c.£2,500 plus VAT.
 - GPR (ground penetrating radar) surveys to identify any buried services would typically be no more than £10k.
 - Topographical reports are typically £500 to collate the information and £500 for an office day to complete the report.
 - Therefore a total of c.£13.5k plus VAT makes the ECC equivalent figure seem very high.
 - Also, the average cost of an ASC according to road safety experts has gone down consistently since 2013, so that element would need to be queried.

23/1707 Report by County Councillor – (Cllr Mike Steel).

- Potholes 39 applications submitted. 3 in the parish, with 1 still to be repaired (at the Cherry Garden Road/South Street junction.
- FE wig wags Cllr Steel was informed of their malfunction in September and is currently
 waiting for the manufacturer to attend and diagnose the fault. Problem may simply be need
 for battery replacement, for which a small budget has been found. Because the devices were

- put in place by the Local Highways Panel (LHP), if a new units are necessary finding a budget would be more difficult in the current climate.
- FEASC 4 years ago Cllr Bentley (the then ECC cabinet member responsible for highways) agreed to overrule policy and accepted that an ASC system could be considered on the B1008 (a PR1 route) if GWPC could contribute 50%. The initial total cost then was around £150k (subsequently negotiated down to c.£120k), and the LHP had a £1m. budget. The offer stood for 2 years, but GWPC was unable to raise its 50% of the costs and this offer then lapsed. Subsequently, Cllr Lee Scott the replacement cabinet member did not renew the previous offer but was willing to consider match funding the scheme when GWPC could show it had raised its half. There is now a new cabinet member in post and an update is due (see 23/1717, below)
 - The precise 'policy' that would need to be overruled is understood to be allowing a scheme to be implemented against ECC officers' recommendations, rather than necessarily articulated in a specific ECC policy.

Doctors' surgery – There is no obvious strategic plan to increase health service provision due to the additional housing (New Beaulieu, Bloor Homes and other developments). The NHS's Integrated Care Board (ICB) are the strategic planners for the services. There is £1.5m held in City Council S106 and CIL accounts and earmarked for the building and commissioning of health services by the NHS, yet some of this money has been held for nearly 10 years old and will go back to developers if is not used at the 10th anniversary.

- The ICB seems to be working on a tactical short-term plan rather than a strategic long-term one.
- RideLondon Returns to Essex and parts of the parish on 26th May 2024.
- Pylons ECC jointly commissioned a report with Suffolk and Norfolk County Councils to focus is on capacity requirements and delivery date timings. It has been suggested the need to have in place additional transmission capacity is closer to 2035, rather than 2030.

23/1708 Report by Chelmsford City Councillor – (Cllr Mike Steel).

- Bloor Homes The link road solution is still the main bottle neck and, seemingly due to the
 economic downturn, clarity from the developer remains outstanding.
- Trucam This is a legal alternative to the police attending for prosecutable speed checks. A trained and licensed council employee can run this. The system does not need either signs or a yellow box, it is an unmarked system. The information is downloaded and sent on to the police for action. Chelmsford City Council will buy in the service from Maldon District Council (who has five trained officers) as a trial. The Parish Council has the potential to itself purchase time off Maldon DC direct. It is understood the set-up cost of a Trucam system is around £18,000 and then ongoing staff payments.

23/1714 Monthly Bank Reconciliation.

Due to a contract dispute this was unavailable.

23/1715 Update on the Action Tracker (circulated with the agenda) – (All).

All open items were reviewed for progress. Having been completed, a number were closed. An updated version of the tracker document will be posted on the website.

23/1716 Discuss the request from a Howe Street resident for a noticeboard.-(Cllr Jackson / Clerk).

The meeting noted the current arrangements and levels of use of the two noticeboards in Howe Street, one at the bus shelter and the other close to Bridge Croft.

Resolution: Remove the noticeboard at Bridge Croft.

Resolution: Leave the current noticeboard in the bus shelter and monitor its use to assess to need for a possible future upgrade.

23/1717 In relation to the Ford End average speed camera scheme, to receive an update of developments, to discuss options, and to agree next steps.

A report has been issued to members for discussion.

The consultation attracted 241 responses. There were two questions. The responses were:

- Q1 Are you in FAVOUR of the Parish Council going ahead with the Average Speed Camera Scheme?
 - YES 183 (75.9% of the votes received).
 - NO 58 (24.1%)

Q2 Are you in FAVOUR of the Parish Council going ahead with the Average Speed Camera Scheme if it includes a Council Tax parish precept increase equivalent to 25p per week/£13 annually (for a Band D property type) for five years for the purpose of repaying the loan?

- YES 159 (66.0%).
- NO − 82 (34.0%).

Update from current ECC cabinet member (Cllr Cunnigham) from Cllr Steel (for context see also 23/1707):

- Essex Highways are unable to proceed with the average speed camera as it does not align with current policies and there is currently no budget available.
- Highways do not have any available funds to support any portion of this scheme. The
 commitment made by Cllr Bentley in 2019 was at a time when LHPs had substantially more
 budget which is not the case now
- Cllr Cunningham would not support any divergence from policy, but if GWPC were able to
 find all the funds he would reconsider his position it if it could also be shown that a scheme
 would improve safety. He would be willing to allow Highway Engineers to revalidate the
 design but it would take a couple of weeks of design effort which GWPC would need to fund.

Resolution: The consultation results give the Parish Council a mandate to seek a loan for the Ford End Average Speed Camera as represented in the consultation.

Resolution: Cllr Steel to contact the senior highways manager to request a meeting with the Parish Council to discuss the design of the scheme and so that it can secure a complete understanding of the issues it needs to address to fully consider the position going forward.

23/1718 To agree to make representations to the landowner to repair and restore the cobbled area adjacent to Walthambury Stores and The Beehive.

Resolution: The Clerk to write a letter to the landowner to seek his views on the future improvement of the area.

23/1719 Discuss and approve any items for publication.-(All).
