A respondent selected option b. to Q.1 and commented the planned picnic area should be 'as shown in picture 1'.

A respondent selected options b. and c. to Q.1 - both have been included.

A respondent selected option a. to Q.2 but expressed a preference for seating *picnic tables* rather than seating *benches*.

A respondent selected option a. to Q.2 but expressed a preference for seating *tables* rather than seating *benches*.

A return form complemented the selection of option a. to Q.3 with the comment 'at least half court basketball court to make it a playable area'.

A respondent complemented the selection of option a. to Q.3 with the comment 'need something for older children'.

A respondent complemented the selection of option c. to Q.3 with the comment 'Basketball area!'

A respondent select a preference for Q.3 (so no count has been recorded), but commented 'How is it going at Gt. Waltham? How many people use the outdoor gym equipment? We should learn from what has happen (sic) at GW'.

A respondent selected option a. to Q.4 and commented 'So dogs don't get in'.

A respondent selected option b. to Q.4 and commented 'Would prefer fencing around the MUGA'.

A respondent selected options a. and b. to Q.3 - both have been included.

A respondent selected option a. to Q.5 and commented 'Great for all weather exercise for all incl. wheelchairs/pushchairs'.

A respondent selected option a. to Q.5 and commented 'Thought there was supposed to be a woodland walk. Public seem to be excluded from the tree area (maybe only until trees are established)'.

A respondent selected an option in Q.5b and commented 'Path needs to be a suitable surface for mobility aids, wheelchairs and pushchairs'.

A return form indicated a preference for [...] Plan 1 with Pic 3. It's children that need equipment. [Re: Q.3] This system is great at Broomfield and well used'.
