

An Update on National Grid Pylons Consultation

from your County Cllr, and City Cllr, Mike Steel:

By the time this article is published, we will have gone beyond the 26th July National Grid (NG) consultation deadline. I hope you all managed to submit objections. This is the statutory consultation, and we need to increase the response rate above the previous 2 non-statutory consultations which were just 0.1% of the population of the 3 counties affected.

There has been a lot of activity from myself and your Local Authorities, and I would like to outline what we have done:

I, personally, proposed a Motion to ECC at the 14th May meeting, to object to the pylons route; but this went beyond just responding to the NG consultation, and I ensured that ECC also sent their objections to Govt (Ofgem) and the Electricity Services Operators (ESO) as their requirements and timescales are influencing the solution.

• Chelmsford City Council maintained their objection and I arranged for this to be presented at the 9th July Cabinet meeting. They focused on the potential harm to residential amenity and in particular the harm to designated heritage assets along the route and the archaeological remains of an Iron Age and later settlements at Ash Tree Corner. I am pleased to say that Parish Councillors attended and supported this.

• The Parish Councils in my ECC division have joined forces to produce a joint response to the consultation as well as advise the 14 Parish Councils on their individual responses. This group, called the North-West Parishes Group (NWPG), regularly meet to coordinate their objections.

 \cdot $\,$ All my Parish councils have logged objections as part of the NG statutory consultation.

• NWPG are going to jointly fund a Landscape Consultant to examine all the NG Environmental Reports to challenge any gaps in their cases.

• NWPG have met with NG to promote alternatives to the currently proposed Overhead Line (OHL) pylons, mainly looking at the East of Chelmsford as an alternative.

• I have met with NG on my own to ensure that the issues around the "Waltham Gap" are fully documented and understood, and alternative routes are considered, as well as alternative technologies, such as HVAC underground (it can be squeezed into a 60m gap!). I am pleased to say that GWPC and LWPC have also pushed on this separately

• I have hosted our MP, Kemi Badenoch, at various locations along the route and shown her the devastating effect of the pylons. Of course, she now acts as our representative for the opposition benches, but I expect her to be vociferous in opposing the OHL route through her constituency.

I am keen that residents are aware that I and your Parish, City and County Councils are working hard to oppose the OHL pylon route.

I understand that once the consultation has closed, the next step will be NG submitting a Development Consent Order (DCO) which is required for Nationally Significant Infrastructure Projects and will be around early 2025. This will include all the consultation feedback, and any related mitigations, although if there is a significant change, such as a change of route, NG may need to re-consult first! Some of us will continue to liaise informally with NG during this period in order to continue to press our case.

You may have also noted that in the King's speech, the new Govt intends to introduce legislation to accelerate planning consents for National Infrastructure projects, which will make our task more even more challenging.

The Fields of Blue

The photo shows the view across the Chelmer Valley from North End – and it has been blue as far as the eye can see for weeks! At first, we thought it might be Linseed or Borage, but it turns out to be Phacelia, which a member of the Borage family and is originally native to North and South America. In this country, I understnad that it is being grown as a cover crop to prevent weed growth, and also as a green manure to improve the soil structure and nitrogen content. The flowers attract bees and other pollinators, so it is

sometimes grown around orchards.





Is your overgrowth causing a problem?

I often get complaints about hedges overhanging pavements and making it dangerous for pedestrians, as they need to step out into the road. Essex County Council are the "Highway Authority" which means that they have a statutory responsibility for the maintenance of adopted roads and footpaths. This includes dealing with overhanging or encroaching vegetation. But most hedges adjacent to the highway/pavement are privately owned and it is the responsibility of the landowner to trim them. Can I ask that landowners keep an eye on their hedges, especially those that overhang the pavement, and that they take action to trim them back. The alternative is that residents can report them here: <u>https://www.essexhighways.org/tell-us</u>.

But if it is privately owned, Highways have to take the longer, expensive and legal route of enforcement and ultimately undertaking the work and then charging the landowner. Much better if we all look at our own hedges and take action for the benefit of the community.

In terms of when hedges can be cut back – you can do this at any time but it is an offence under Section 1 of the <u>Wildlife and</u> <u>Countryside Act of 1981</u>, to intentionally take, damage or destroy the nest of any wild bird while it is in use or being built. The main bird breeding season is between March and August and the risk of committing any of the above offences is increased between these dates. That doesn't stop anyone trimming hedges during this period but if you undertake any work within these dates, you should check the hedge for any signs of breeding activity first.



Please, have a look at your hedge and make sure you aren't causing pedestrians to step into the road to avoid an overhanging hedge!

Amongst the rich heritage, which is a distinguishing feature of The Hundred Parishes, there are many ancient houses that were built originally as a "hall house", sometimes referred to as an "open hall house". Many surviving houses that were built between the mid-13th and early 17th centuries had a standard three-part layout: a central 'open hall' flanked by two cross-

wings. The crosswings were of two storeys and were the same height as the single-storey hall that linked them. Individual houses sometimes had variations to this basic design. Daily life for members of the household was a communal affair, focused on the large central hall. It was heated by a fire that burned on a central hearth, its smoke rising to escape through vents in the roof. The use of a chimney to remove smoke generally came only in the 16th or 17th century. The crosswing at one end of the household and their immediate family. The other crosswing was a service area, accessed from a passage with front and back doors at either end. The passage also gave entry to the hall, from which it was partly screened. Each wing had its own stairs to the upper floor of that wing. Between about 1550 and 1650 AD, the open hall concept became less popular, with a desire

for more privacy. Most open halls were remodelled with the insertion of a floor to make them two storeys. The open hearth was replaced with a fireplace and chimney.

Postal Votes during the General Election Mike Steel

I thought it might be worth updating residents on the postal vote situation that came to light during the run up to the election.

Many people I spoke to, said that they had not received their postal vote with just a week to go to polling day. I called Uttlesford District Council (UDC) several times to raise my concerns but was initially told that they had all gone out. It later transpired that 2,600 postal votes had not been printed and despatched, all in the area that covers Writtle, Broomfield and the Walthams, Boreham and the Leighs and Chelmsford Rural West. On realising this, UDC printed them all and put them in the post with less than a week to go.

Some people did not get them until the day before the election. I broadcast on social media that voters needed to immediately return them or take them to the polling station on the day. Of course, many people who were away, lost the chance to vote.

I spoke to the CEO of UDC at the count, and 77% of the affected votes did manage to get their vote back in time (standard expectation is 75%). Fortunately, the win margin was much greater than the unreturned votes, otherwise there woulld have been a case for appeal!

This is a summary of some items discussed at the June monthly meeting of the Parish Council. For more details, see the full and approved minutes of all Council meetings, available on our notice-boards and the parish website (e-voice.org.uk/greatwalthamparish).

We received representations from residents concerning the village green located at the southern end of Church Lane, Ford End, at its junction with the main road (B1008). The Parish Council is the registered owner of this land, as recorded by Essex County Council in the Register of Town and Village Greens under reference VG150. We noted an adverse possession claim has been made on the green with the Land Registry. Residents raised concerns over the fence and hedge which have been installed on VG150 without our permission. We also noted that Essex Highways claim highway rights extend to 5-6 metres of the verge, and that they do not allow fencing and hedges to be planted where such rights exist unless a licence has been granted, and even then only provided visibility for road users is not impeded or a hazard has not been created. We agreed to make available from our reserves an initial sum of £1,000 to cover any legal fees incurred challenging the adverse possession claim.

Our ECC councillor Mike Steel confirmed that under the member-led pothole repair scheme, defects he had nominated, such as the remedial work between Pendon Hill and Pleshey, would commence on 23rd June. He also confirmed the school wig-wag lights at Ford End have been repaired and are operational again. In his city councillor role, Mike confirmed CCC would be looking to agree its response to National Grid's consultation before the revised deadline date of 26th July.

We resolved to take advantage of the offer from the landlord of our allotment sites to permit both a restructuring of how the rent element is charged to a plot holder as part of the overall annual hiring fee, and to allow residents from neighbouring parishes to take up vacant plots, that are not required by Great Waltham parishioners.

Our next monthly meeting will be on Monday 19th August at the Pavilion, Great Waltham Recreation Ground, starting at 7.00pm. As always, all parishioners are welcome to attend our public meetings.
