Applications:

• 06/2022/0353: Outline application for 4no. Dwellings seeking approval for access and layout (all other matters reserved), Sumners Farm, Cow Hill. Application No. 06/2021/1044 for five dwellings was proposed for the same

site (actually slightly smaller than for the current application) and subsequently withdrawn last year. Following consultation of all members of the council, it was agreed that HPC should maintain its objection for exactly the same reasons, ie., failure to comply with policies EN1 and EN4 of the Local Plan, and lack of sustainability owing to remoteness from transport links and services. Were this application to be approved, this part of Cow Hill would have the appearance of a suburban street, when viewed together with the 5 dwellings that have already gained approval on the site of the derelict barn and adjacent to it.

• 06/2022/0536: Application No. 06/2022/0260: Proposal: Conversion of an existing garage to 1no. dwelling, insertion of two dormer windows, roof lights and juliet balcony to rear following demolition of existing outbuilding. Site Address: Savick House, Whittingham Lane, Haighton, Preston PR2 5RP. This appeared to be an identical application to 06/2022/0260 which had been refused on 4/5/22, therefore the Clerk assumed members' objection to the application would be unchanged.

The Annual Audit had been prepared by the Clerk.

Certificate of Exemption:

Annual Audit-Statement of Assurance

• The Annual Governance Statement was completed after discussion of each question and approved by all members. It was then signed by the Chairman and Clerk.

Annual Audit-Accounts:

- The accounting statements for YE 31/3/22 were approved by all members and signed and dated by the Chairman and Responsible Financial Officer (the clerk).
- The Annual Internal Audit Report had been completed by Mr P Derbyshire after examining the parish council's accounts.
- The Notice of Appointment of Date for the Exercise of Elector's rights will be displayed along with the Audit documents from 21/6/22 to 29/7/22. The accounts will then be available for inspection by electors between the hours of 4.00pm and 6.00pm.

The Annual Precept:

• No remittance advice statement had been received from PCC. However, it is assumed that the precept will be forthcoming.

Payments:

- Cheque No.352 for £57.51 paid in favour of LALC for this year's subscription.
- Cheque No.353 for £200.41 paid in favour of Zurich Municipal for the renewal of this years' insurance cover.

Community Infrastructure Charge Payments:

• E-mail received from Mr Drew Gough, CIL Monitoring Officer, PCC. He wished to know if HPC's bank account details were the same as those shown in PCC's records in order to transfer £9545.44 for two of the dwellings recently built on land adjacent to The Paddock, Whinfield Cottage, Cow Hill. The two dwellings, 'Benfield' and 'Tomfield' each generated a CIL levy of £4772.72. The Clerk explained to Mr Gough that HPC had no public facilities, such as playing fields, village hall, etc., nor any land on which to create any. Mr Gough said that the money would go into PCC's funds for improvements to Fishergate etc. in Preston city centre.
