We would support development of the site, however, we have significant concerns of over development of the site and significant concerns of inadequate amenity space. We would be sympathetic of replacing the buildings with place appropriate and sympathetic architecture. We would support a smaller development with fewer, more appropriate dwellings. We note that this is an opportunity to address the hazardous telephone pole adjacent to this land, on the priority 2 road.

e) Proposed single- storey extensions to west and north elevations. Single storey link extension to connect dwelling to existing garage and extension to garage. Proposed detached single storey summer house, proposed cartlodge. Change of use of part of meadow land to residential. Erection of garden wall and gates.
