The Parish Council supports the conversion of redundant agricultural buildings, however, there are serious concerns over the total demolition and rebuilding of a substantial property, there is also serious concern over the excess use of glazing, lastly, there are serious concerns that the removal of the current evergreen trees will diminish the current screening they provide, as the new trees indented to be planted are slower growing native trees.
