- Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at Causeway House, Bocking End, Braintree, Essex, CM7 9HB by 5 pm on Monday, 15th April 2019.
- Applications to vote by proxy at this election must reach the Electoral Registration Officer at Causeway House, Bocking End, Braintree, Essex, CM7 9HB by 5 pm on Wednesday, 24th April 2019.
- Applications to vote by proxy at this election applied for on grounds of physical incapacity, where that physical incapacity occurred after 5 pm on Wednesday, 24th April 2019, must reach the Electoral Registration Officer at Causeway House, Bocking End, Braintree, Essex, CM7 9HB by 5 pm on Thursday, 2nd May 2019.
