## 169.2018/19 District/County Councillors' reports

DCIIr W. Scattergood – mindful of upcoming elections, nothing in report of a political nature. Update on mobile mast in Twinstead. Reported that the Planning Dept had had difficulties uploading large files to the planning website, which delayed the objection document. The Chairman thanked DCIIr W. Scattergood for her assistance in a grant application for the new noticeboards.

CCIIr D. Finch (also mindful of upcoming elections) gave a comprehensive report on extra funding within the county. £500.000.00 to help deal with County Lines crime, £250,000.00 to Homeless issues, £700,000.00 for footpaths and pavements, £1,000,000.00 for mental health Issues.

According to an RAC survey Essex CC were highly rated in dealing with potholes and had reduced there number in the County by 45%

The potholes on Church Rd, Twinstead have been inspected and reported by CCllr D. Finch. In a survey conducted by ImPower with regard to efficiency in spending public money Essex CC were rated 7<sup>th</sup> out of 150.
