On behalf of Cllr A. Smart, it was agreed that the tree pruning needed on Twinstead Green would be undertaken next year. An application to the Local Services Fund will be made to cover the financial cost of this

136.2017/18 Highways/PROW maintenance

Highways survey to be completed by Cllr T. Humphreys Cllr M Cracknell questioned the resurfacing of the driveway at Sheepcote, Middleton. He pointed out that part of the driveway is a public highway. Clerk to enquire to Highways

137.2017/18 To consider correspondence received/matters for report

The Cllr's agreed that all emails received by the Clerk should continue to be circulated

The offer of free fruit trees for community orchards, received via the Countryside Projects Officer for DVAONB and SVP was discussed. Unfortunately, no areas within the Parishes could be identified

Cllr T. Humphreys raised concern over the proposed distribution of new powerlines in relation to the development of Sizewell C. Cllr R. Barnes is to attend a public meeting in the near future

Cllr T. Humphreys is to complete the Police Precept Survey

It was suggested that the signed off Minutes from Parish Council meetings should be published in the local Parish magazine. This is to be trialled for six months to gage public response

Litter Picking - Cllr A. Lyster advised that we are contravening an 1870's act of Parliament and will be investigating this further. Cllr A. Lyster is to contact all groups that carry out the litter picking to explain the legal obligations involved. Cllr. A. Scattergood is to check through the insurance policy to confirm whether or not volunteers are covered under Public Liability Cllr. T. Humphreys to gather quotes for the installation of two new noticeboards (one in Little Henny and the other in Henny Street). Cllr T. Humphreys to ascertain whether there is a funding scheme to help cover the cost. A working party, arranged by the Parish, will undertake the groundworks to save on costs
