# 2. Update on matters arising in previous meeting and recent activities

## Cycle storage

Four new hangars installed - advised that possibly two spaces left; Peter O'G seeking updated list of who else wants bike storage - if more, further bid for funding via Thriving Neighbourhoods possible Resident raised query as to certainty that existing and new storage is actually in use - has contacted Homes and Communities but no response. Advised by Keith Facey that Asset Management Team have now taken over allocation of bike storage (as well as pram sheds and garage spaces) so all queries related to these should be sent to <a href="mailto:AssetManagementTeam@islington.gov.uk">AssetManagementTeam@islington.gov.uk</a>. Question raised as to whether contact point for requesting space could be put on hangars (and other relevant spaces).

Jack M (committee member) working with Jade to install more noticeboards across the estate (currently paper-based noticeboards only present in five-storey blocks)

# Playground and multi sport court area

Thriving Neighbourhoods bid for new surface for court and to update equipment not successful. However IBC Special Projects Team (led by Melody Walker) looking into updating equipment (as some wood now corroding) and possibly adding equipment aimed at toddlers/young children - TRA have been in contact and have offered support for this

Concern raised that tree house being used to take laughing gas (canisters seen in vicinity)

### Anti-social behaviour

Suspected drug deals have been spotted taking place at Birchmore Walk/Highbury New Park area and near bus stop
Threshold for police action - six reports within two week period therefore important to keep reporting suspected drug dealing/activity via 101 or online Met Police crime reporting system (if not an emergency) with as much detail re: dates, times, individuals/vehicles involved as is safe to gather)
Resident had made report about drug taking to IBC ASB reporting systems and had been told that block letter would be sent out but nothing received

IBC also review persistent incidences over three month period based on reports made to <a href="ASB reporting systems">ASB reporting systems</a> - this was how Riversdene problems were tackled **so important to keep reporting** so that other services such as <a href="ParkGuard">ParkGuard</a> can be engaged Also reports of joyriding around Highbury Quadrant and flytipping Jade working with Tenancy Services about specific issue involving resident - actions taken could include tenancy being revoked but only after following due process

Raised in AOB - people smoking in stairwell of 193-231 Highbury New Park (has been reported to police and ASB line) - whilst not a complete solution, advised that increasing movement in stairwells (if safe to do so) can help deter this

#### Wildflower meadows

First area (nearest to Highbury New Park) is ready for planting - to have seeds stamping event with local children; other two areas to be worked on next year

# 3. Caretaking standards

More communication/collaborative working with Estate Services via quarterly inspections (open to all residents) and weekly bulletins from Jade - can be made public to residents Issues raised:

- HQ maisonettes only have caretaker three days a week so some activities (such as washing stairs) not done - Jade reported plans to recruit to the part-time vacancy
- 1-11 Birchmore Walk had caretaker (John) who was excellent but then moved on and new caretaker not as effective (took four weeks to remove rubbish and not cleaning balcony/stairs - has been reported)

Jade highlighted that balconies (unlike stairs and lobby areas) are not covered by caretaking activities (are responsibility of residents) but should clear environmental health hazards such as fox faeces (note access to 1-11 Birchmore Walk difficult due to current door)

Current caretakers - Mark, John, Yusuf, Roger, Alister and Peter (part-time Mon-Wed - looking to recruit to vacancy for Thurs-Fri) covering 8-4 or equivalent

Question raised about what residents can expect from caretaking services and if not met, how can this be reflected in fees charged - Jade provides hours worked to Home Ownership who then provide charges (though unclear as to who manages this) - residents don't feel there has ever been any reimbursement

Councillors have asked for letter to be sent out about what to expect from caretaking service

Overall feeling from residents that voices are not heard and action not taken when raising issues; also some frustration related to quality of work undertaken in the stated hours; question also raised about the morale of the caretakers - residents wanted to be clear that feelings about the service were because we all care about the estate and want it to be at its best

Keith Facey offered to organise a resident drop-in event (most probably 4-7pm at Birchmore Hall) where there could be representation from Home Ownership and other IBC departments such as Community Safety to enable residents to meet directly with key services - positive response in the room to this.

# 4. Bin storage redesign

Funding from Thriving Neighbourhoods scheme will enable initial feasibility study to look at existing arrangements and options for enclosing waste bins (Highbury Quadrant unique because have internal recycling chutes but waste bins are outside - note question as to why these were configured in this way - aim had been to improve recycling rates and TRA at the time had been involved in consultation around this)

Considerations will include aesthetics, hygiene, fire safety (enclosures would need to be secure and fire safe), capacity, location (needs to be
