In response to a resident's question on whether hydrant testing still takes place, Essex County Fire & Rescue confirmed that they test all statutory hydrants in High Easter, they are tested on a three and half year cycle. 19.129.03 – Update on affordable housing project including points raised at the December meeting

19.129.04 – Uttlesford has confirmed a special Planning Committee meeting will be held on Friday 24 January 2020 to consider matters relating to the Stansted Airport planning application.

'On line with the Council resolution made on 28 June 2019, the Planning Committee will meet to consider the adequacy of the S106 Agreement – this is the package of legally-binding planning obligations which are attached to the planning permission to off-set its impact – as well as any potential new material considerations since the committee resolved to grant the application in November 2018. The committee will need to determine whether to authorise the release of a decision notice formally approving the application. Ahead of the committee date, Uttlesford District Council will host a public speaking session to allow people more opportunity to express their views on the relevant issues directly to representatives of the Planning Committee. The session will take place on Friday 17 January 2020. Further details about the public speaking session and the arrangements for the special Planning Committee, including how to register to speak, will be issued in due course. The committee report will be published in advance of the public speaking session.

A meeting of SSE Town and Parish Council Liaison Group has been called for Wednesday 8th January at 8pm in Great Easton village hall; this is in response to the announcement above. Cllr Davis will attend on behalf of High Easter Parish Council.

19/130 FOOTPATH DIVERSIONS

Uttlesford has sent notification of two applications for footpath diversions,

- i. Footpath 16, a minor relocation to divert the path around Crippings Farm rather than through the farmyard.
- ii. Footpath 23, a diversion south at its current junction with footpath 74 until its intersection with footpath 75. A diversion of footpath 76, south along its entire length from footpath 74 to byway 19. This moves the current footpath route away from Haydens Farm.

Parish Council to consider any comments.

19/131 BUDGET 2020/21 and QUARTERLY REPORT FOR 2019/20

A final decision on the level of precept to set for 2020/21 including whether to increase precept for one year only to ensure sufficient funding to replace the play equipment. Approximately £21k is now available in Parish

Council funds with the estimate for the new equipment and surfacing at £30k. Increasing the precept from £11,400 (2019/20 level) to £21,400 would increase the payment for an average band D property from £33 to £61.62 for the year.

19/132 PLAY AREA EQUIPMENT

The Parish Council has been successful in its grant application to the Uttlesford Community Project Scheme and has been awarded £3.5k towards the play area, this has a deadline for usage of 31st March 2020.

Parish Council to consider next steps.

19/133 ADOPTION OF THE PHONE BOX AND FUTURE USE

BT has sent a draft contract for the purchase of the phone box. Clerk to present a review of the current condition of the phone box prior to the Parish Council agreeing to the terms of the contract. In addition, there are various requirements of the Parish Council in terms of notification and insurance. BT has confirmed once the contract is signed arrangements will then be made to remove the equipment.

Parish Council to consider future options for the kiosk use.
