This Order is made by the Essex County Council ("the authority") under section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that the footpath described in paragraph 1 below is not needed for public use.

Uttlesford District Council have been consulted and have consented to the making of the Order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way over the land situated at Hayden's Farm known as Footpath 75 High Easter in the District of Uttlesford and shown by a bold continuous line on the order map numbered HEAST 75X attached to this order and described in the Schedule to this Order be extinguished after 28 days from the date of confirmation of this Order.
2. Notwithstanding paragraph 1 of this Order any statutory undertakers shall still have rights over the land referred to in paragraph 1 above.

Plan No. HEAST 75X

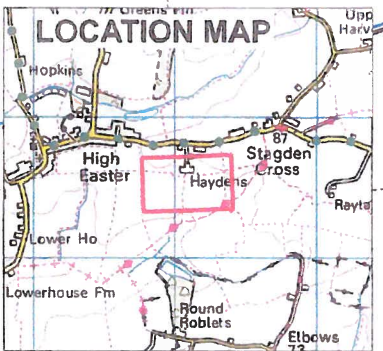
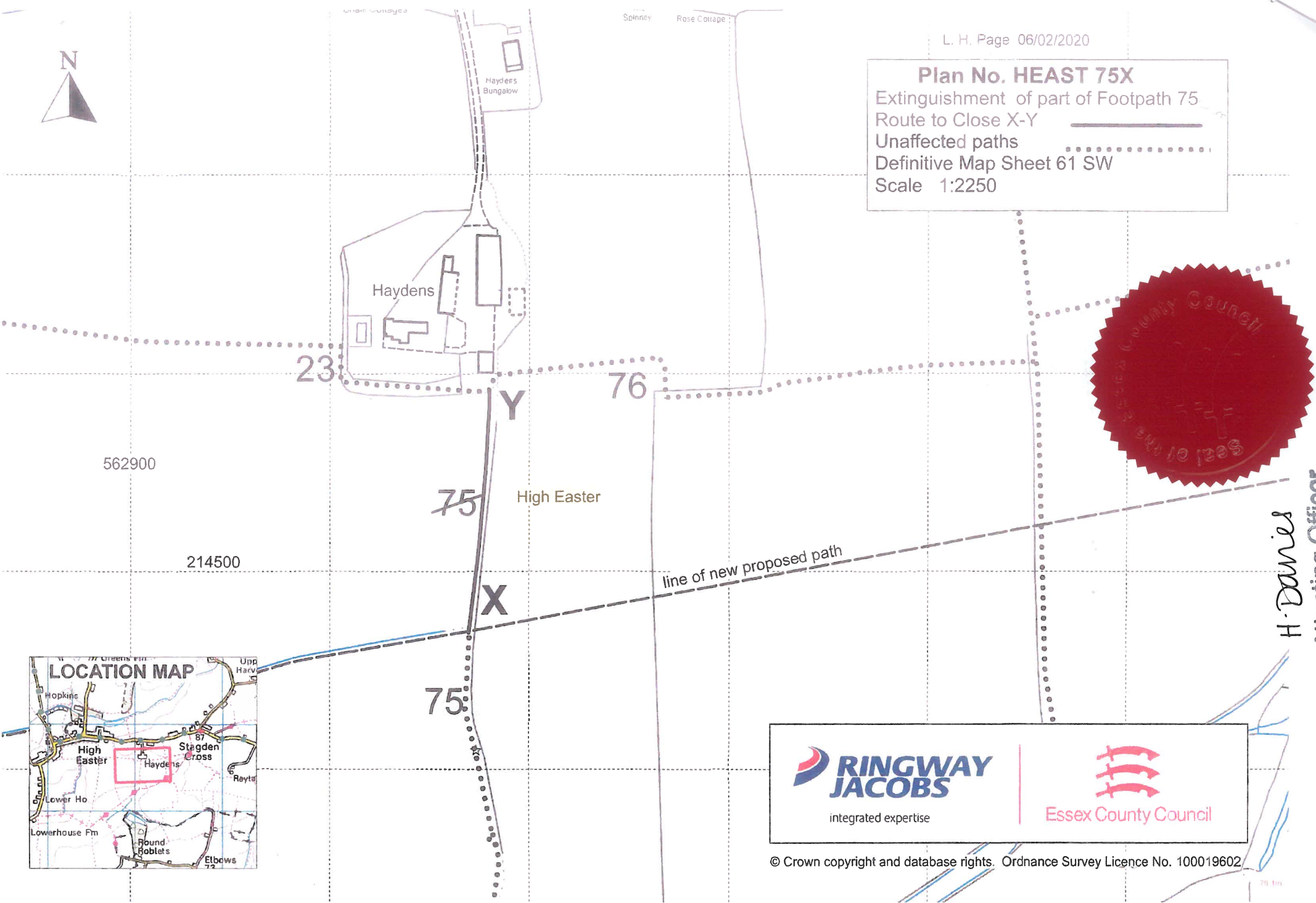
Extinguishment of part of Footpath 75
