

## HIGH EASTER PARISH COUNCIL

### MINUTES OF THE ORDINARY MEETING OF THE PARISH COUNCIL

held at High Easter Village Hall on Monday, 1<sup>st</sup> December 2025 at 07:30pm

Present: Cllrs Robert Lodge (Chair), Nigel Boreham (Vice Chair), Lucy O'Connor, Neil Reeve, Wendy Colgrave, Janet Robinson and the Clerk, Oliver Rogers.

7 residents were in attendance.

The Chair, Cllr Lodge opened the meeting at 6.35pm.

#### **25/110 APOLOGIES FOR ABSENCE**

None.

#### **25/111 DECLARATION OF INTERESTS FOR THIS MEETING**

Cllr O'Connor declared a personal interest in planning application UTT/25/3145/LB (item 25/117).

#### **25/112 PUBLIC FORUM (Maximum 15 minutes)**

Chair brought forward the discussion on Wheats Farm due to the number of interested residents.

Clerk read factual information from UDC planning officer:

- Class Q (agriculture to residential) maximum limits increased in June 2024 to 10 dwellings up from 8 and floorspace from 852 metres squared to 1000 metres squared
- Class Q only applies to the prior notification applications **UTT/25/2914/PAQ3** and **UTT/23/3211/PAQ** **crucially not to** UTT/24/1572/FUL and UTT/23/1059/FUL
- UTT/23/3211/PAQ for approval of the prior notification of 5 buildings on the chicken shed in December 2024
- **UTT/25/2914/PAQ3 is actually an increase of 2 dwellings and a revision of the already approved UTT/23/3211/PAQ for the chicken shed**

District Cllr Susan Barker said that she was not allowed to call this in to committee as prior notification is decided on strict criteria by officers.

Cllr Lodge opened the floor to the public at 6.43pm.

Jon Hunting from Arceland Green Bed and Breakfast said there was no notices posted publicly around the site and parking would be difficult and light likely to cause a nuisance. He said residents accepted that something would be developed on the site and this was potentially to have been 5 buildings and since then it has grown.

Mr Hunting highlighted a [planning case from Oxfordshire](#) that clarified the distinction between Class Q conversion of buildings and rebuilding on the site of a demolished building. The case found that if the works amount to a rebuild then the conversion is not permitted by Class Q.

Chair took the assembled through the proposed comments that the Parish Council could make.

The owner of Wheats Farmhouse, Mr Farrow, applying in a separate planning application for change of use from agriculture to residential for a field area adjacent to the farmhouse and for permission to build an annexe spoke to the meeting. He said he had lived in the area for a long time and grew up in Little Easton and that his parents would live in the annexe. He said there was space should they need carers at a later stage.

**25/113 MINUTES OF ORDINARY PARISH COUNCIL MEETING** held on Monday, 3<sup>rd</sup> November. The meeting **resolved and agreed** the minutes as a record of the proceedings.

#### **25/117 PLANNING APPLICATIONS [See APPENDIX A below]**

The Chair brought forward this agenda item for the benefit of the residents in attendance.

The meeting **resolved and agreed** to make the following comments and objections to the planning applications considered in Appendix A.

Councillors were reminded that the Parish Council is a statutory consultee to planning applications and that as a result it is important that all planning applications are noted and added to the minutes after consideration by the full council meetings.

#### **25/114 COUNTY AND DISTRICT CLLRS REPORT**

Electricity cable works have been causing problems on the High Easter Road at Bishop's Green and the surrounding farmland and verges.

Essex County Council will set a budget in February 2026. Spend is not on adult social care anymore it is on SEND children.

#### **25/115 COUNCILLORS REPORTS**

To receive reports on the following from lead Cllrs.

- *Planning including Local Plan* – Cllr Colgrave
- *Highways including highway safety* – Councillors resolved and agreed that a further letter about parking on The Street should be drafted and sent to residents

- *Uttlesford liaison* – Cllr Reeve – confirmed that he would undertake an inspection of the playground area

- Training update - the Clerk noted that he had now completed the training courses required at the start of his contract. A Probationary Meeting has been arranged with Cllr Colgrave and Cllr O'Connor on Monday 8<sup>th</sup> December to discuss the next steps for training and development.

### **25/120 LOVE YOUR BUS**

Cllr Lodge updated the meeting on the reason for the delay in starting the revised bus route. This was due to delays at the Department for Transport and Essex County Council.

Further information to be brought forwards at the next meeting *[The bus route variation will now start on 6<sup>th</sup> January 2026 following confirmation of the changes from the DfT's Traffic Commissioner]*.

### **25/121 SEATED EXERCISE CLASS EXTENSION**

25.121.01 – Councillors discussed and **resolved to reject** a plan to run a trial of the Seated Exercise Class on a Thursday in the New Year.

25.121.02 – Councillors discussed and **resolved to reject** the purchase of a portable freestanding [barre bar](#) for use at the classes (Total cost: £149.99). This was refused due to safety concerns.

Cllr Colgrave added that more local residents should be encouraged to take part and Cllr Lodge said that an approach should be made to local parish councils for funding to support their residents attending the group.

Councillor commented that any underspend could be used to pay in advance for venue hall and food costs across the term. The Clerk to action points raised.

### **25/122 FINANCE [See APPENDIX B]**

25.122.01 To approve the payment of the below payments including a donation to the Poppy Appeal as requested by the pilots for the fly pass and a donation to St Mary's Church, High Easter as requested by Kate Hargreaves, Tangle and Thyme at Greens Farm for the creation of the natural Remembrance Sunday wreath.

25.122.02 Meeting to note that the current account balance is **£15,784.49** and the saving account balance is **£60,832.20** as of 24<sup>th</sup> November.

The Clerk noted that the changes to the banking mandate had been made with Coop Bank and the Clerk was now able to set up the payments for approval as per the decision made at the meeting in November 2025.
