2024/25.66 Apologies for Absence

2024/25.69 Minutes of the Previous Meeting

It was unanimously resolved that the minutes of the meeting held on 10th July were a true record and were signed accordingly.

2024/25.70 Public Participation Session

2024/25.71 Reports and Members Reports

a) Chairman's Report - None

b) Vice Chairman's Report - None

c) District & County Councillors Reports – Cllr Mary Dadd advised that she had not yet received an update regarding the extra parking requested for the new Mill Lane site, and suggested that if S106 moneys could not be used for the purpose of extra parking then this Council look into possible off street parking or funding opportunities. Cllr Dadd also advised that from 1st November the refuse centre will be operating out of North Weald. Cllr Dadd also provided a detailed update on the planning changes coming into effect on 1st October.

d) Parish Councillors -

- Ward Councillor Report Paslow Common Cllr Burton advised that she had seen quite a few complaints on the village WhatsApp group regarding speeding through the Village. Cllr Dadd suggested contacting Bill Stock, who is a retired police officer who often helps rural villages to tackle speeding. The Clerk confirmed she would chase County Councillor Jaymie McIvor regarding the 20 is plenty campaign.
- <u>- Ward Councillor Report High Ongar</u> Cllr Arthur advised that there was a fly tipping incident at the bottom of Mill Lane, however before he could report it the waste was removed. Cllr Funnell advised that as you enter High Ongar from Chelmsford Way a sign has been kicked and broken where the white fences are. The Clerk confirmed she would take a look at this and report it.

e) Highways Report—Councillors raised concerns regarding the large HGV lorries and tractors that drive through High Ongar Village. Cllr Dadd advised that Ongar Town has an Ongar Neighbourhood Plan Community Group Road Subcommittee where they have been campaigning since 2017 to tackle this issue, should a representative from High Ongar Parish Council wish to join. Cllr Caitlin confirmed he would be interested in joining. The Clerk confirmed she would get the details from Cllr Dadd and pass them on to Cllr Caitlin.

<u>f) High Ongar Village Hall – Cllr Funnell</u> advised that the Village Hall had a few updates over the last few months, including all lino repaired and paving slabs cleaned. He also provided an update on the Village Halls new regular weekly hirer FreeFood4U.

2024/25.72 Clerk's Report

All matters were included within the body of the agenda.

2024/25.73 Financial Regulations

Councillors reviewed the NALC 2024 Financial Regulations that were attached to the agenda. It was unanimously agreed by members to adopt these Financial Regulations which had been adapted to suit the Council's needs.

2024/25.74 Play Area Funding

Councillors were asked to discuss the future installation of a play area within High Ongar and its Location. Councillors agreed to defer this matter to the October meeting.

Cllr Burton advised that the Cuciana Italian were unable to match the quote received from the previous caterers. It was agreed to move forward with booking the pervious caterers. The Clerks also confirmed that she would liaise with Cllr Caitlin to draft a poster for the event.

2024/25.76 Zurich 2024/2025 Insurance Renewal

Councillors unanimously agreed the 2024/2025 Insurance Renewal with Zurich Insurance.

2024/25.77 Banking arrangement

Over the past six months the Clerk has noticed banking with Lloyds Bank isn't as easy or as smooth as other Banks which many other Parish Councils use. The majority of Councils now bank with Unity Trust Bank who provide a very efficient and easy system of operation. The Clerk advised that the cost to Bank with Unity Trust is £72 per year, however can be opened, operated and accessed remotely. It was Proposed by Cllr Funnell and Seconded by Cllr Arthur to move over to Unity Trust Bank.

The Clerk also advised that Unity Trust also offer a savings account alongside the current account with a 2.7% interest rate. The Clerk confirmed she would put this as an agenda item for next meeting for Councillors to consider.

2024/25.78 New High Ongar Website

Councillors agreed to defer this matter to the October meeting.

2024/25.79 Changes to planning at EFDC

As reported earlier in the meeting by Cllr Dadd, EFDC has now agreed changes to how planning decisions will be made at Local Planning Authority level. The changes will mean that the Parish Council will have to ensure that if it wishes to object to a planning application, clear reasons material to the planning merits of the application will need to be detailed, and for the objection to be considered at an EFDC Planning Committee meeting the Parish Council must also state their
